


Producer price Index

Third quarter, 2021

Tirana, on 07 December 2021: In the third quarter 2021, Producer Price Index reached 103.2 increasing by 4.3 % compared with third quarter 2020.

Producer Price Index in the third quarter 2021 increased by 1.8 % compared with second quarter 2021.

Annual change: Compared to the third quarter of 2020, the largest price increase of 10.7% is observed in the section "Extractive industry" followed by the sections "Electricity, gas, steam and air conditioning" by 3.6%. Price Index of Production in the section "Manufacturing" has increased by 2.4%. Within this section, the largest increase of prices is observed in the activity "Metallurgy" with 7.8%, followed by the activities "Other transport equipment" with 4.4%, "Production of rubber and plastic products" with 3.9% etc. On the other side, the largest decrease in prices is observed in the section "Printing and regrouping of recorded media" by 3.0%, followed by sections "Manufacture of electrical equipment" by 1.5%, "Production of optical, electronic products, computers" by 1.3% etc.

Producer Price Index for Domestic Market: Compared to the third quarter of 2020, the index increased by 3.3%. The largest increase of prices is observed in the section "Extractive industry" with 8.5%, followed by the section "Electricity, gas, steam and air conditioning" with 2.7%, the section "Manufacturing" with 2.3% and section "Water supply, waste treatment and management activities, waste" by 0.3%.

Export price index: Compared to the third quarter of 2020, the index increased by 7.1%. The largest price increase of 42.3% was recorded in the section "Electricity, gas, steam and air conditioning", followed by the section "Extractive Industries" with 18.7%, the section "Water supply, treatment activities and waste management" with 13.2% and the section "Processing Industry " with 2.0%.

Quarter changes: Compared to the previous quarter 2021, the largest increase of 7.8% is observed in the section "Extractive Industries". Producer Price Index, in the section "Manufacturing" has increased by 1.3%. Within this section, the largest increase in prices is observed in the activity "Other transport equipment" by 4.8%.

Producer Prices Index for Domestic Market: Compared to the second quarter of 2021, the index increased by 1.5%. The largest increase is observed in the section "Extractive Industries" with 7.9%.

Export Price Index: Compared to the previous quarter, the index increased by 9.5%. The largest increase of 35.6% is observed in the section "Electricity, gas, steam and air conditioning".

Metodology

INSTAT calculates Producer Price Index for Domestic Production and Export Price Index. Calculation and publication of Producer Price Index in Albania include:

- Producer Price Index in Total
- Producer Price Index for Domestic Production
- Export Price Index

Producer price index measures the change in the prices of products at the first point of sale after production. Producer Price Index is compatible with Eurostat methodology and covers following economic activities:

- Section B - Extracting industry
- Section C - Manufacturing industry
- Section D - Electric power, water and gas
- Section E - Water supply, treatment activities and waste management

These indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA) in 6 – digit level and are published in two digit level. Renovation of the basket of enterprises and products is based on the results of Annual Structural Survey of Enterprises. For calculation of products 'weights of Producer Price Index for Domestic Production are used data coming from SBS while for calculation of products' weights of Export Price Index are used data coming from Foreign Trade Statistics.

Producer Price Index (PPI) is calculated taking into consideration 2020 as base year (2020 = 100). Calculation's method used in compiling of this index is Laspayer chain – index. It means that each transaction will be compared with its previous year December price (y -1).

Index calculation

For calculation of index is used Laspeyer type and is calculated as following:

- The first part before the equal sign is stating the price level of December 2020 in percent of the average price level during 2020. hence adjusting the average of 2020 to 100.
- The second term is the chained index movement from December 2020 to December y-1 (a product of yearly index links [short-term - links] from December to December).
- The last part is showing the movement from December y-1 to month m year y.

Measures of index

The annual change measures the price change between the current quarter and the same quarter of previous year. This measures is responsive to recent changes in price levels but can be influenced by one – off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
