	Statistics on foreigners in Albania consider any person, with or without citizenship, who, according to the Albanian legislation, is not an Albanian citizen.
3.1. Data description	The purpose of the annual publication of foreigners in Albania is to present the results and indicators on foreigners with residence permits in Albania, by age group and sex, reason for application, countries of origin and the annual number of applications for residence permits. The publication also features irregular foreigners.
	 The data series on foreigners contain statistical information on: Foreigners with residence permits in Albania by country of origin. Foreigners with residence permits in Albania by sex. Foreigners with residence permits in Albania by age group. Foreigners with residence permits in Albania according to the reason. for the application.

	 Irregular foreigners by country of origin. Foreigners with residence permits by continents. Applications for Residence Permit in Albania by country of origin. Applications for Residence Permit in Albania by length of validity.
3.2. Classification system	The citizenship classification is based on the list of ISO-3166 codes (using alpha-2) with minor changes. These changes consist of small changes that have occurred over time to reflect the creation of new countries or citizenships. In some cases, these categories of citizenship are not universally recognized, but are used recognized by Albania.
3.3. Sector coverage	Statistical information covers data on foreigners with residence permits by country of origin, the reason for the application, continents, sex, age group as well as by applications for residence permit in the Republic of Albania.
	Foreigner is any person, with or without citizenship, who, according to the Albanian legislation, is not an Albanian citizen.
	Residence Permit is a document issued by the competent authorities which authorizes and permits a foreigner to stay in the Republic of Albania for more than 90 days within 180 days.
	Stateless person is the person who does not have the nationality of any state.
3.4. Statistical concepts and definitons	Work permit is the authorization issued by the responsible state authority to a foreigner, for business purposes, to be employed, self-employed or for professional training.
	Family reunification is the entry and stay in the Republic of Albania of family members of an Albanian citizen, who do not have Albanian citizenship or a foreigner or a refugee resident in the Republic of Albania, with the purpose of maintaining the family, regardless of whether the family relationship is established before or after the entry of a foreigner into the Republic of Albania, in cases of family reunification of the foreigner's family.
	Family members of a foreigner, asylum seeker, refugee or person under subsidiary protection are their spouse, cohabitant, whose cohabitation has a stable and proven character; minors, unmarried children, part of the family composition including those deprived of custody and who are in custody of him or her or adopted by a court decision or a decision that is enforced directly, according to the international obligations of the Republic of Albania or to be recognized, in accordance with international obligations, as well as unmarried adult children when they cannot objectively meet their needs due to their health status; first-line ancestors in the right line, when they are in charge of him or his / her spouse, according to the legislation of origin and do not enjoy the proper family support in the country of origin.
	Volunteer's service is a program of solidarity activities, based on activities recognized in the Republic of Albania, in pursuit of objectives of general interest.
	Researchers and specialists are foreigners with specialized knowledge, essential, for service, research equipment and a high level of qualification for the activity exercised by the enterprise or research institution.

	Irregular stay is the presence in the territory of the Republic of Albania of a foreigner who does not meet or no longer meets the conditions for entry, stay or residence in the territory of the Republic of Albania.
	State or place of origin is the state whose citizenship is held by asylum seekers or refugees and, in the case of stateless persons, the country in which the refugee or asylum seeker has his habitual residence.
3.5. Statistical unit	The statistical unit is individuals.
3.6. Statistical population	Foreigners statistics refer to foreign individuals with residence permits in Albania as well as irregular foreigners.
3.7. Reference area	Territory of Republic of Albania.
3.8. Time coverage	Time series of Foreigners in Albania are annually published, starting from 2017 onwards. Aggregated data cover the entire territory of the country. Data are available from 2005 onwards.
3.9. Base period	Not applicable.

5. Reference period	This report refers to 2021.
6. Institutional mandate	
6.1. Legal acts and other agreements	 The legal basis for the production of indicators of Foreigners in Albania is part of the legal basis of INSTAT: Official Statistics Law No.17/2018; Official Statistics National Program 2022-2026; The definitions are based on: Law No.79/2021 "On Foreigners"
6.2. Data sharing	Actually there is no data sharing in European level.
7. Confidentiality	
7.1. Confidentiality - policy	The data are considered confidential and used only for statistical purposes and scientific research in accordance with Law no. 17/2018 ON OFFICIAL STATISTICS, as well as Law no. 9887, dated 10.03.2008 "Protection of Personal Data". Article 31 of the Law on Official Statistics clearly states that all statistical information collected by INSTAT is confidential and may be used or published only in summary tables that do not identify the source unit of information. Direct identification is called when a statistical unit is directly

	identified by the name, address or any officially recognized identification number. When data processing is carried out in such a way as to enable the data subject to be identified, the data must be coded immediately so that the entities are no longer identifiable.
	Albanian Institute of Statistics protects and does not disseminate data it has obtained or it has access to, which enable the direct or indirect identification of the statistical units. Albania Institute of Statistics takes all appropriate preventive measures so as to render impossible the identification of individual statistical units by technical or other means that might reasonably be used by a third party. Statistical data that could potentially enable the identification of the statistical unit are disseminated by Albania Institute of Statistics if and only if: a) these data have been treated, as it is specifically set out in the Regulation, in
7.2. Confidentiality -	such a way that their dissemination does not prejudice statistical confidentiality or b) the statistical unit has given its consent, without any reservations, for the
data treatment	The confidential data that are transmitted to Albania Institute of Statistics are used exclusively for statistical purposes and the only persons who have the right to have access to these data are the personnel engaged in this task. Issues referring to the observance of statistical confidentiality are examined by the staff working in Albania Institute of Statistics. The responsibilities of this staff are to recommend on: which detailed level the statistical data can be disseminated, so as the identification, either directly or indirectly, of the surveyed statistical unit is not possible; the anonymization criteria for the microdata provided to users; the access granting to researchers on confidential data for scientific purposes.

8.1. Release calendar	Notifications about the dissemination of statistics are published in the release calendar, which is available on the website. The announcements and delays are pre-announced in this calendar. In the case of delays, the date of the next publication and the explanation of the reasons for the delays are specified.
8.2. Release calendar access	The Calendar of publications is available on the INSTAT website.
8.3. User access	In accordance with article 34 of Law No. 17/2018 "On Official Statistics", official statistics are disseminated so that all users have an immediate and equal right and all possible forms of media are used. INSTAT and statistical agencies, having in the program the responsibilities of dissemination, seek to 6 meet every requirement of any organization or individual for unpublished data or specific analysis. 10.1. News release	According to the calendar of publications, the data of the Foreigners in Albania, are published annually with a separate publication, on specific dates. The publication is available on the official website of INSTAT, in the statistical database Px-Web, also distributed electronically to users. Public announcements and delays in the publication calendar. In case of delays, other publication data and explanation of the reasons for the delays are specified.

10.6. Documentation on methodology	A brief explanation of the definitions, key concepts and methodological explanations for users is published in the press release and publications. 11.1. Quality assurance	INSTAT is committed to ensure the highest quality with respect to the compilation of statistical information. In accordance with the Statistics Law, INSTAT use statistical methods and processes in compliance with 7 internationally recognized scientific principles and standards conduct ongoing analyses of the statistics with a view to quality improvements and ensure that statistics are as up to-date. In performing its tasks it follows the general principles of quality management from the European Statistics Code of Practice. INSTAT declares that it takes into account the following principles: impartiality, quality of processes and products, user orientation, employee

	orientation, effectiveness of statistical processes, reducing the workload for

11.2. Quality assessments	Quality controls and validation of data are actions carried out throughout the process. The data source for Foreigners in Albania Statistics is administrative. The data are compared with data from previous years to determine if there is data coherence or there have been major changes.
12. Relevance	
12.1. User needs	The publication of data on foreigners is widely used by users mainly for evidence-based policy planning, because foreigners figures are used to analyze a range of indicators both social and economic, by different users among which the most important are: • Central government • Local government • Academic field • Ordinary users Information on users' needs for, and their perceptions of foreigners is measured in several ways: • Page Views (Hits) on the relevant product on the INSTAT website. • Meetings with different users allowing them to discuss their requirements and needs. • Contacts with users who individually contact the Population Statistics sector on their specific requests, or send to INSTAT their requests regarding statistics on foreigners.
12.2. User satisfaction	Page Views (Hits) about "Migration and migrant integration" in 2021 are around 10.343 clicks. During 2021, INSTAT conducted the user satisfaction survey. The results of the survey shows that the quality of "Migration and migrant integration" was rated 3,48 (69.6%) on a scale of 1 (very poor) to 5 (very good). INSTAT organizes every year <u>User Satisfaction Survey</u>
12.3. Completeness	The completeness of the data for Foreigners in Albania statistics for 2021 is judged by comparing the quality and quantity of indicators in the Official Statistics Program (2022-2026). The Completeness rate of Foreigners, in 8 Albania Statistics for 2021 is 100%.
13. Accuracy and reliab	ility
13.1. Overall accuracy	In general, the data have been checked with previous years to identify any significant changes in the performance of the data. In cases where changes are encountered, INSTAT notifies the relevant data sources to inform about the findings found in order to correct this data if deemed necessary or to be

	officially confirmed.
13.2. Sampling error	Not applicable.
13.3. Non - sampling error	The non-sampling errors are mainly errors of the administrative data sources reported data. Data review occurs only if the relevant institutions review the data sent to INSTAT for the purpose of updating or any potential human error. If the relevant institutions review the data sent to INSTAT, these changes will be reflected in the nearest publication and brief explanatory information will be provided to users.

15.2. Comparability - over time	Statistics for Foreigners in Albania date back to 2005 referring to the statistical database, providing a long time comparison of 17 years (CC2 = Jlast-Jfirst + 1 = 17). The data are constantly checked to ensure their comparability over time.

Frequency of data Frequency of data collection is done in annual frequency. collection Data on Foreigners in Albania are data from an administrative source. The Institute of Statistics organizes the work for the calculation of indicators and 18.3. Data collection statistics on Foreigners in Albania for 2021, oriented by the Official Statistics Program and the Law on Statistics. Department of Border and Migration is the main source of data for all indicators published under this program. The data were logically and mathematically checked.
