

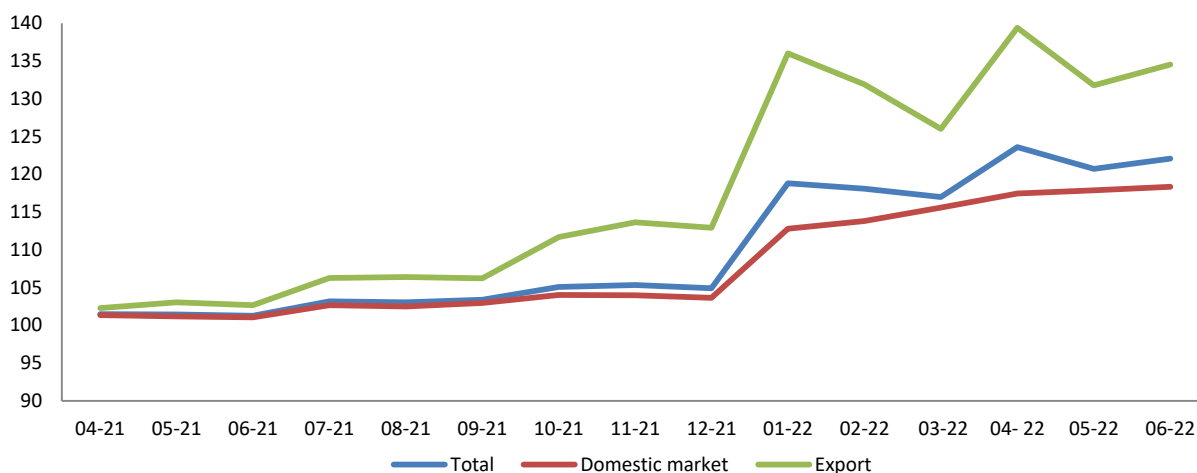
Producer price Index

Second quarter, 2022

Tirana, on 07 September 2022: In the second quarter 2022, Producer Price Index reached 122.1 compared to 2020. Compared to the second quarter of 2021, the Producer Price Index increased by 20.5 %, a year ago this change was 1.6 %.

Producer Price Index in the second quarter 2021 increased by 3.3 % compared with first quarter 2022.

Annual change: Compared to the second quarter of 2021, the largest price increase of 44.9 % is observed in the "Mining and quarrying" section, followed by the "Electricity, gas, steam and air-conditioned" sections with 28.5 %. The Index of Production Prices in the "Manufacturing" section has increased by 16.9 %. Within this section, the largest increase in prices is observed in the activity "Production of non-metallic mineral products" with 30.9 %, followed by the activities "Processing of coke and refinery of petroleum by-products" with 28.6 %, "Production of products fabricated metal, except machines and equipment" with 25.2 %, "Processing of pharmaceutical products and preparations" with 23.6 %, etc. On the other hand, the biggest decrease in prices is observed in the section "Production of electrical equipment" by 6.3 %, followed by the sections "Production of vehicles, trailers and semi-trailers" by 2.3 % and "Production of optical products", electronics, computers" with 0.2 %.

The Index of Production Prices of products for the domestic market: Compared to the second quarter of 2021, the index increased by 16.5%. The biggest increase in prices is observed in the section "Mining and quarrying" with 26.7%, followed by the section "Processing industry" with 21.5%, the section "Electricity, gas, steam and air conditioning" with 13.9%. The section "Water supply, waste treatment and management activities, and waste" recorded a decrease of 0.1%, compared to the second quarter of 2021.

Production Price Index of products for export: Compared to the second quarter of 2021, the index recorded an increase of 31.7%. The largest increase in prices was recorded in the "Electricity, gas, steam and air conditioning" section, followed by the "Mining and quarrying" section with 60.4%, the "Water supply, waste treatment and management" section with 28.8% and the "Manufacturing" section with 10.9%.

Quarterly change: Compared to the first quarter of 2022, the largest increase of 9.8% is observed in the "Mining and quarrying" section. The Index of Production Prices, in the "Manufacturing" section, increased by 1.4%. Within this section, the largest increase in prices is observed in the activities "Other transport equipment" with 7.3%, "Manufacture of woods and products of wood and oak, except furniture; Manufacture of articles of straw and reed" by 6.0%, etc.

Index of Production Prices of products for the domestic market: Compared to the first quarter of 2022, the index increased by 2.2%. The biggest increase is observed in the "Mining and quarrying" section with 4.3%.

The Index of Production Prices of products for export: Compared to the previous quarter, the index increased by 4.4%. The biggest increase of 12.5% is observed in the "Mining and quarrying" section.

Methodology

INSTAT calculates Producer Price Index for Domestic Production and Export Price Index. Calculation and publication of Producer Price Index in Albania include:

- Producer Price Index in Total
- Producer Price Index for Domestic Production
- Export Price Index

Producer price index measures the change in the prices of products at the first point of sale after production. Producer Price Index is compatible with Eurostat methodology and covers following economic activities:

- Section B - Extracting industry
- Section C - Manufacturing industry
- Section D - Electric power, water and gas
- Section E - Water supply, treatment activities and waste management

These indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA) in 6 — digit level and are published in two digit levels. Renovation of the basket of enterprises and products is based on the results of Annual Structural Survey of Enterprises. For calculation of products „weights of Producer Price Index for Domestic Production are used data coming from SBS while for calculation of products“ weights of Export Price Index are used data coming from Foreign Trade Statistics.

Producer Price Index (PPI) is calculated taking into consideration 2020 as base year (2020 = 100). Calculation's method used in compiling of this index is Laspayer chain-index. It means that each transaction will be compared with its previous year December price (y -1).

Index calculation

For calculation of index is used Laspayer type and is calculated as following:

$$I^{y.m}_{2020} = \frac{100}{12 \sum_{Dec} I^{F.M}_{F-1.Dec F=2020}} + I^{F.M}_{F-1.Dec}^{y-1} * I^{y.m}_{y-1.Dec}$$

- The first part before the equal sign is stating the price level of December 2020 in percent of the average price level during 2020, hence adjusting the average of 2020 to 100.
- The second term is the chained index movement from December 2020 to December y-1 (a product of yearly index links [short-term - links] from December to December).
- The last part is showing the movement from December y-1 to month m year y.

Measures of index

The annual change measures the price change between the current quarter and the same quarter of previous year. This measure is responsive to recent changes in price levels but can be influenced by one-off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
