

# **Movements of citizens in Albania**

# September 2022

**Tirana, 25 October 2022:** Arrivals of Albanian and foreign citizens to the territory of Albania, in September 2022 are 1,208,667. This indicator increased by 52.2 %, compared to September 2021. In September 2022, arrivals of foreign citizens to the territory of Albania are 761,544. This number increased by 54.1 %, compared to September 2021 (tab.1).

## Citizen's arrivals

In September 2022, from the countries with the highest inflows of citizens to Albania, Spain had the largest increase by 3.8 times and North Macedonia by 3.3 times, compared to September 2021.

During the nine months of 2022, among the countries with the highest inflows of citizens in Albania, Spain has had the largest increase of 4.0 times and United Kingdom by 2.0 times, while Switzerland had the lowest growth by 11.5 %, compared with the same period of 2021 (tab.2).




Fig. 1 Movements of citizens in Albania

### **Citizen's departures**

Albanian and foreign citizen's departures from the territory of Albania during September 2022 are 1,371,621 marking an increase by 42.7 %, compared to the same period of the previous year. Departures of Albanian citizens from the territory of Albania during September 2022 are 541,216. Compared to September 2021, this number has increased by 47.6 %.

Departures of foreign citizens from the territory of Albania during September 2022 are 830,405. Compared to September 2021, this number increased by 39.6 % (tab1).

The number of Albanian citizens leaving the territory of Albania during the nine months of 2022 is 4,390,611 increasing by 36.2 %, compared with the same period of 2021 (tab1).

In September 2022, the number of foreign nationals entering the territory of Albania for "Personal" purposes is 744,366, increasing by 53.6 %, compared to the same period of the previous year (tab2).

During the nine months of 2022, the arrivals and departures of Albanian and foreign citizens according to the mode of travel are presented:

### Number of citizen's arrivals:

- From air points has increased by 83.9 %, compared to the same period of the previous year;
- From sea points has increased by 47.3 %, compared to the same period of the previous year;
- From land border points has increased by 25.3 %, compared to the same period of the previous year.

#### The number of citizen's departures:

- From air points has increased by 86.5 %, compared to the same period of the previous year;
- From sea points has increased by 57.0 %, compared to the same period of the previous year;
- From land border points has increased by 28.8 %, compared to the same period of the previous year (tab3).

# Methodology

The purpose of the publication for arrivals and departures of Albanian and foreign citizens, by means of transport (sea, air, land and border points), is the measurement of some statistical indicators related to tourism.

## Definitions

**Arrivals:** Include all entries at the border points (by, air, sea and land). Arrivals is a concept that refers to all entries. A person who visits some countries simultaneously during the year is counted every time as a new entry.

**Departures:** Includes all exits at the border points. Departures measure the flow of citizens who leave the country of reference. A person who leaves the country of reference several times during a year is always counted as a new exit.

**Visitor:** For statistical purposes on tourism, the term "visitor" represents a "person who travels in a different place from that in which he resides, in a period shorter than 12 months and major aim of travel in the place visited is a non-profit activity".

The purpose of the trip includes visits of visitors and tourists for:

Visits for *personal purposes* grouped as follows:

- 1. Holidays, visit to relatives etc.;
- 2. Health treatment
- 3. Religious;
- 4. Tranzit.

Visits for *Business category* includes all business and professional activities outside the usual environment.

**Data Source**: Administrative data are provided by the Ministry of Internal Affairs (State Police, Border and Migration Directorate).

The statistical differences between arrivals and departures of Albanian or foreign nationals come mainly from:

- Law No.71 / 2016 "On Border Control", Article 17 "Facilitation of Border Verifications", where during the tourist season or increased inflow, at the moment of entry of citizens at the border, does not register all the incoming citizens;
- The facilitating procedures applied to residents of border areas crossing the border due to their commercial activity, when they cross several times a day, are not registered at the entrance;
- A good share of Albanians hold dual citizenship, who at the time of border crossing may declare different citizenship at exit from it at the entrance, etc.
