

Consumer Price Index

October 2022

Tirana, on November 08, 2022: Consumer Price Index in October 2022 arrived 111.2 against December 2020 as reference period.


The annual rate of consumer price index in October 2022 is 8.3 %, a year before was 2.4 %. Compared with September 2022 the monthly change of consumer price index is 0.4 %.



Contribution of main groups in yearly changes of CPI: Annual growth rate in October was influenced mostly from prices of group "Food and non-alcoholic beverage" by +5.09 p.p., followed by "Transport" group contributed by +1.00 p.p.. Price of "Housing, water, electricity and other fuel" by +0.70 p.p.. Price "Furniture household goods and maintenance" group contributed by +0.48 p.p.. Price "Alcoholic beverages and tobacco" group contributed by +0.28 p.p.. Price "Hotels, coffee-house and restaurants" group contributed by +0.27 p.p.. Prices of "Miscellaneous goods and services" group contributed by +0.19 p.p.. Price of "Clothing and footwear" group contributed by +0.12 p.p.. Prices of "Recreation and culture" group contributed by +0.06 p.p.. Price of "Health" and "Education service" groups contributed by +0.05 p.p. each of them. Price of "Communication" group contributed by +0.02 p.p..

Yearly rates of main groups: Compared to October 2021, prices increased the most in the group "Transport" by 16.9 % followed by "Food and non-alcoholic beverage" by 14.6 %, "Furniture household goods and maintenance" by 6.5 %, "Hotels, coffee-house and restaurants" by 6.1 %, "Alcoholic beverages and tobacco" by 5.7 %, "Housing, water, electricity and other fuel" by 3.6 %, "Miscellaneous goods and services" by 3.3 %, "Clothing and footwear" by 3.0 %, "Education service" by 1.8 %, "Recreation and culture" by 1.7 %, "Health" by 1.3 %, "Communication" by 0.7 %.

Within the food group prices of "oil and fats" subgroup signed an increased by 27.4 %, followed by "milk, cheese and eggs" by 24.3 %, "bread and cereals" by 17.1 %, "fish" by 15.3 %, "sugar, jam honey, syrup, chocolates and sweets" by 14.7 %, "meat" by 12.4 %, "vegetables included potatoes" by 11.8 %, etc.

Monthly rates of main groups: Compared with September 2022 prices of "Transport" increased by 1.5 %, followed by "Furniture household goods and maintenance" by 0.8 %, "Housing, water, electricity and other fuel" by 0.6 %, "Clothing and footwear" by 0.5 %, "Food and non-alcoholic beverage" and "Health" by 0.4 % each of them, "Miscellaneous goods and services" by 0.2 %, "Hotels, coffee-house and restaurants" by 0.1 %. The most decrease of the prices was noticed in the "Recreation and culture" group by 2.5 %, followed by "Alcoholic beverages and tobacco" and "Education service" by 0.4 % each of them.

METHODOLOGY

- Methodological changes

In January of each year some methodological changes and new developments were carried out in CPI:

- Update of weights: Weights are changed; they are now based on the average expenditure from 2020 Household Budget Survey.
- Update of basket: The list of goods and service content 331 products.
- Update of list of the outlets where the prices are collected is updated.

Started from January 2021, the consumer price index is calculated with the new base period. December 2020 is considered as the base period (December 2020 = 100).

INSTAT during the Pandemic period has been following the latest recommendation coming from EUROSTAT and other international partners.

- Definitions

The annual rate measures the price change between the current month and the same month of the previous year. This measure is responsive to recent changes in price levels but can be influenced by one-off effect in either month

The monthly rate measures the price change between current month and previous month. Although upto-date it can be affected by seasonal and other effects.

The 12-month average rate compares average Consumer Price Indices and the latest 12 month to the average of the previous 12 months.
