


Foreign Trade in Goods

December 2022

Tirana, January 17, 2023: On December 2022 the value of exports was ALL 40 billion, increasing by 26.1 % compared with the same period of previous year and decreasing by -4.5 % compared with November 2022. The value of imports was ALL 95 billion, increasing by 7.7 % compared with the same period of previous year and by 22.3 % compared with November 2022. This month the trade deficit is ALL 54 billion, decreasing by -2.9 % compared with December 2021 and increasing by 54.2 % compared with November 2022.

In 2022, the value of exports was ALL 487 billion, increasing by 32.0 %, compared with previous year and the value of imports was ALL 950 billion, increasing by 18.7 % compared with previous year. Trade deficit was ALL 464 billion, increasing by 7.3 % compared with the same period of 2021.

The influence of the main groups in the annual change in exports:



In annual increase of exports by 26.1 % this month, a positive contribution was given by the groups: "Mineral, fuels, electricity" with +17.5 percentage point, "Food, beverages, tobacco" with +4.0 percentage point and "Machinery, equipment and spare parts" with +3.0 percentage point. While a negative contribution was given by the group: "Construction materials and metals" with -2.5 percentage point.

Page 2 Foreign Trade in Goods December 2022 Fig.2 Contribution of groups in annual change of exports December 2022




Exports during the year 2022 are increased by 32.0 % compared with the same period of previous year. The main groups that influenced more in annual increase of exports are: "Mineral, fuels, electricity" with +10.3 percentage point, "Construction materials and metals" with +6.9 percentage point, and "Textile and footware" with +6.2 percentage point.

The influence of the main groups in the annual change in imports:

In annual increase of imports by 7.7 %, this month has mainly affected the groups: "Minerals, fuels, electricity" with 9.6 percentage point and "Machinery, equipment and spare parts" with +3.8 percentage point. While a negative contribution was given by the groups: "Chemical and plastical products" with -2.8 percentage point, "Construction materials and metals" with -2.1 percentage point and "Textile and footwear" with -0.5 percentage point.

In 2022, imports are increased by 18.7 % compared with the same period of previous year. The groups affected positivity in annual increase of imports, are: "Mineral, fuels, electricity" with +8.3 percentage point, "Construction materials and metals" with +3.2 percentage point and "Food, beverages, tobacco" with +2.4 percentage point.

The performance of trade in goods by partner countries


In December 2022, countries with which Albania has had the highest increase of exports, compared to December 2021 are: Italy (0.8 %), Macedonia (273.6 %) and Kosovo (17.5 %). While, country with which has had a decrease of imports is: Germany (16.5 %).

In 2022, countries with which Albania has had the highest increase of exports, compared to the same period of 2021 are: Italy (35.1 %), Kosovo (0.2 %) and Germany (58.6 %). While, country with which has had a decrease of imports is: Spain (0.9 %).

In December 2022, countries with which Albania has had the highest increase of imports, compared to December 2021 are: Switzerland (690.2 %), Turkey (2.7 %), and China (43.4 %). While, countries with which has had a decrease of imports are: Italy (7.9 %), Greece (25.1 %) and Kosovo (20.0 %).

In 2022, countries with which Albania has had the highest increase of imports, compared to the same period of 2021 are: Italy (5.9 %), Turkey (33.1 %) and China (18.8 %). While, countries with which has had a decrease of imports are: USA (10.3 %), Russia (27.3 %) and Austria (1.1 %).





Trade with the EU countries in December 2022 is 51.5 % of total trade. In December 2022, exports to EU countries occuped 66.2 % of total export and imports from EU countries occuped 45.2 % of total import. The main trade partners remain: Italy (24.0 %), Switzerland (11.1 %), Turkey (7.7 %), and China (7.3 %).

Trade with the EU countries, in 2022 is 59.0 % of total trade. In this period, the share of exports to EU countries was 73.4 % of total export and share of imports from EU countries was 51.6 % of total import. The main trade partners are: Italy (29.0 %), Turkey (8.4 %), Greece (6.9 %) and Germany (6.3 %).

Methodology

Exports are goods destined to a third country. placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed. or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
