Foreign Trade in Goods

January 2023

Tirana, February 16, 2023: On January 2023 the value of exports was ALL 42 billion, increasing by 20.2 % compared with the same period of previous year and by 4.6 % compared with December 2022. The value of imports was ALL 58 billion, increasing by 5.8 % compared with the same period of previous year and decreased by -38.5 % compared with December 2022. This month the trade deficit is ALL 16 billion, decreasing by -19.4 % compared with January 2022 and by -70.3 % compared with December 2022.




Fig.1 Annual change in Foring Trade (%)

The influence of the main groups in the annual change in exports:

In annual increase of exports by 20.2 % this month, a positive contribution was given by the groups: "Mineral, fuels, electricity" with +12.9 percentage point, "Textile and footwear" with +3.7 percentage point and "Machinery, equipment and spare parts" with +1.6 percentage point. While a negative contribution was given by the group: "Chemical and plastical products" with -0.8 percentage point.







Fig.2 Contribution of groups in annual change of exports January 2023

The influence of the main groups in the annual change in imports:

In annual increase of imports by 5.8 %, this month has mainly affected the groups: "Machinery, equipment and spare parts" with +4.1 percentage point, "Chemical and plastical products" with +1.8 percentage point and "Food, beverages, tobacco" with +1.3 percentage point. While a negative contribution was given by the groups: "Wood manufactories and article of paper" with -1.0 percentage point, "Construction materials and metals" with -1.0 percentage point and "Textile and footwear" with -0.2 percentage point.

The performance of trade in goods by partner countries

In January 2023, countries with which Albania has had the highest increase of exports, compared to January 2022 are: Macedonia (207.5 %), Kosovo (31.4 %) and Greece (81.6 %). While, country with which has had a decrease of imports is: Italy (4.1 %), Germany (17.7 %) and China (24.2 %),.

In January 2023, countries with which Albania has had the highest increase of imports, compared to January 2022 are: China (27.4 %), Germany (16.2 %), and U.S.A. (67.1 %). While, countries with which has had a decrease of imports are: Italy (12.3 %), Turkey (4.4 %) and Greece (7.1 %).




Fig.4 ForeignTrade in Goods by several EU countries January 2023

Trade with the EU countries is 57.3 % of total trade. In January 2023, exports to EU countries occuped 68.8 % of total export and imports from EU countries occuped 48.9 % of total import. The main trade partners remain: Italy (27.5 %), Turkey (7.2 %), and Greece (7.0 %).

Foreign Trade in Goods

Methodology

Exports are goods destined to a third country. placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed. or are left in warehouse, under customs procedure of release for free circulation. inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country. or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
