


# **Producer price Index**

### First quarter, 2023

**Tirana, on 06 June 2023:** In the first quarter 2023, Producer Price Index reached 129.5 compared to 2020. Compared to the first quarter of 2022, the Producer Price Index increased by 9.4 %, a year ago this change was 17.0 %.

Producer Price Index in the first quarter 2023 increased by 1.5 % compared with fourth quarter 2022.

Annual change: Compared to the first quarter of 2022, the largest price increase of 18.3 % is observed in the "Electricity, gas, steam and air-conditioned" section, followed by the "Mining and quarrying" section with 13.0 % and "Manufacturing Industry" section by 7.0 %. Within this section, the largest increase in prices is observed in the activity "Paper printing and regrouping of recorded media" by 25.4 %, followed by the activities "Manufacturing of woods and products of wood and oak, except furniture; manufacture of articles of straw and reed" by 15.1%, "Manufacture of non-metallic mineral products" with 13.2 %, "Other transport equipment" by 11.4 %, etc. On the other hand, the biggest decrease in prices is observed in the activity "Manufacture of transport vehicles, trailers and semi-trailers" with 4.0%, followed by the activity "Manufacture of coke and petroleum products refinery" with 2.8 %.

Domestic

The Index of Production Prices of products for the domestic market: Compared to the first quarter of 2022, the index increased by 9.3 %. The biggest increase in prices is observed in the section "Mining and quarrying" with 21.3 %, followed by the section "Manufacturing industry" with 10.8 %, the section "Electricity, gas, steam and air conditioning" with 6.3 % and the section "Water supply, waste treatment and management activities" with 0.4 %.

**Production Price Index of products for export:** Compared to the first quarter of 2022, the index recorded an increase of 9.1 %. The largest increase in prices was recorded in the "Electricity, gas, steam and air conditioning" section with 34.7 %, followed by the "Water supply, waste treatment and management activities, waste" section "with 15.7 %, "Mining and quarrying" with 4.1 % and "Manufacturing Industry" section with 2.7 %.

**Quarterly change:** Compared to the fourth quarter of 2022, the largest increase of 2.5 % is observed in the "Mining and quarrying" section, followed by the "Electricity, gas, steam and air conditioning" section with 1.9 %, the sections "Manufacturing industry" and "Water supply, waste treatment and management activities, waste" with 1.1 % each other. Within the section "Manufacturing industry", the largest increase in prices is observed in the activities "Manufacture of food products" with 3.4 %, "Manufacture of fabricated metal products, except machinery and equipment" with 2.0 %, etc.

**Index of Production Prices of products for the domestic market:** Compared to the fourth quarter of 2022, the index increased by 1.6 %. The biggest increase is observed in the "Mining and quarrying "section with 3.8 %.

The Index of Production Prices of products for export: Compared to the previous quarter, the index increased by 0.9 %. The biggest increase of 8.7 % is observed in the "Water supply, waste treatment and management activities, waste" section.

## Methodology

INSTAT calculates Producer Price Index for Domestic Production and Export Price Index. Calculation and publication of Producer Price Index in Albania include:

- Producer Price Index in Total
- Producer Price Index for Domestic Production
- Export Price Index

Producer price index measures the change in the prices of products at the first point of sale after production. Producer Price Index is compatible with Eurostat methodology and covers following economic activities:

- Section B Extracting industry
- Section C Manufacturing industry
- Section D Electric power, water and gas
- Section E Water supply. treatment activities and waste management

These indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA) in 6 - digit level and are published in two digits level. Renovation of the basket of enterprises and products is based on the results of Annual Structural Survey of Enterprises. For calculation of products weights of Producer Price Index for Domestic Production are used data coming from SBS while for calculation of products" weights of Export Price Index are used data coming from Foreign Trade Statistics.

Producer Price Index (PPI) is calculated taking into consideration 2020 as base year (2020 = 100). Calculation's method used in compiling of this index is Laspayer chain - index. It means that each transaction will be compared with its previous year December price (y -1).

### Index calculation

For calculation of index is used Laspeyer type and is calculated as following:

- The first part before the equal sign is stating the price level of December 2020 in percent of the average price level during 2020. Hence adjusting the average of 2020 to 100.
- The second term is the chained index movement from December 2020 to December y-1 (a product of yearly index links [short-term links] from December to December).
- The last part is showing the movement from December y-1 to month m year y.

#### Measures of index

The annual change measures the price change between the current quarter and the same quarter of previous year. This measures is responsive to recent changes in price levels but can be influenced by one - off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
