

# **Foreign Trade in Goods**

# **July 2023**

Tirana, August 16, 2023: On July 2023 the value of exports was ALL 38 billion, decreasing by -4.0 %, compared with the same period of previous year and by -0.6 %, compared with June 2023. The value of imports was ALL 71 billion, decreasing by -13.6 %, compared with the same period of previous year and by -6.0 %, compared with June 2023. This month the trade deficit is ALL 33 billion, decreasing by -22.6 %, compared with July 2022 and by -11.6 %, compared with June 2023.




In the first seven months of 2023, the value of exports was ALL 272 billion, decreasing by -7.0 %, compared with previous year and the value of imports was ALL 509 billion, decreasing by -3.5 %, compared with previous year. Trade deficit was ALL 237 billion, increasing by 0.8 %, compared with the same period of 2022.

#### The influence of the main groups in the annual change in exports:

In annual decrease of exports by -4.0 % this month, a contribution was given by the groups: "Constructions materials and metals" with -8.7 percentage point, "Textile and footwear" with -1.8 percentage point, "Wood manifacturing and article of paper" with -1.1 percentage point, etc. While a positive contribution was given by the group: Mineral, fuels, eletcricity" with +6.9 percentage point and "Food, beverages, tobacco" with +2.0 percentage point.

Exports during the seven months of 2023 are decreased by -7.0 % compared with the same period of previous year. The main groups that influenced more in annual decrease of exports are: "Constructions materials and metals" with -7.0 percentage point, "Minerals, fuels, electricity" with -1.0 percentage point, "Chemical and plastical products" with -0.9 percentage point, etc. While a positive contribution was given by the group: "Food, beverages, tobacco" with +2.1 percentage point, "Machinery, equipment and spare parts" with +0.6 percentage point, etc.

#### The influence of the main groups in the annual change in imports:

In annual decrease of imports by -13.6 %, this month has mainly affected the group: "Minerals, fuels, electricity" with -6.8 percentage point, "Constructions materials and metals" with -3.4 percentage point, "Chemical and plastical products" with -2.8 percentage, etc. While a positive contribution was given by the groups: "Machinery, equipment and spare parts" with +2.8 percentage point, etc.




Fig.3 Contribution of groups in annual change of imports, July 2023

In the first seven months of 2023, imports are decreased by 3.5 % compared with the same period of previous year. The groups affected negativity in annual increase of imports, are: "Minerals, fuels, electricity" with -4.8 percentage point and "Constructions materials and metals" with -1.3 percentage point, "Food, beverages, tobacco" with -0.6 percentage point, etc. While a positive contribution was given by the groups: "Machinery, equipment and spare parts" with +4.1 percentage point, "Chemical and plastical products" with +0.1 percentage point, etc.

#### The performance of trade in goods by partner countries


In July 2023, countries with which Albania has had the highest decrease of exports, compared to July 2022 are: Italy (10.6 %), Austria (78.4 %) USA (63.4 %). While, country with which has had a increase of imports is: Kosovo (24.3 %), Greece (12.2 %), United Kongdom (1632.8 %).

In the first seven months of 2023, countries with which Albania has had the highest decrease of exports, compared to the same period of 2022 are: Italy (10.6 %), Germany (23.8 %), China (32.7 %), etc. While, countries with which has had a increase of exports are: Kosovo (7.7 %), Greece (15.6 %), Spain (57.9 %), etc.

In July 2023, countries with which Albania has had the highest decrease of imports, compared to July 2022 are: Italy (7.4 %), Turkey (16.3 %), Greece (29.8 %), etc. While, countries with which has had a increase of imports are: China (10.1 %), Germany (6.5 %), USA (28.2 %), etc.

In the first seven months or 2023, countries with which Albania has had the highest decrease of imports, compared to the same period of 2022 are: Turkey (18.2 %), Greece (14.9 %), Italy (4.3 %), etc. While, countries with which has had a increase of imports are: China (34.5 %), Switzerland (79.5 %), USA (45.6 %), etc.

Trade with the EU countries is 59.2 % of total trade. In July 2023, exports to EU countries occuped 75.6 % of total export and imports from EU countries occuped 50.9 % of total import. The main trade partners remain: Italy (31.2 %), China (7.8 %), Germany (6.6 %), and Greece (6.5 %).

Trade with the EU countries, in the first seven months of 2023 is 59.5 % of total trade. In this period, the share of exports to EU countries was 73.8 % of total export and share of imports from EU countries was 51.8 % of total import. The main trade partners are: Italy (30.4 %), China (7.6 %), Turkey (6.8 %) and Greece (6.7 %).

# Methodology

Exports are goods destined to a third country. placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are diretcly placed. or are left in warehouse. under customs procedure of release for free circulation. inward processing or processing under customs control.

The cost. insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country. or the price of a service delivered to resident. before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
