

# **Consumer Price Index**

### October 2023

**Tirana, on November 08, 2023:** Consumer Price Index in October 2023 arrived 115.4 against December 2020 as reference period.


The annual rate of consumer price index in October 2023 is 3.8 %, a year before was 8.3 %. Compared with September 2023 the monthly change of consumer price index is 0.1 %.

Contribution of main groups in yearly changes of CPI: Annual growth rate in October was influenced mostly from prices of group "Food and non-alcoholic beverage" by +2.64 p.p., followed by of "Furniture household goods and maintenance" group by +0.39 p.p.. "Housing, water, electricity and other fuel" group contributed by +0.32 p.p.. Prices of "Hotels, coffee-house and restaurants" group contributed by +0.21 p.p.. Prices of "Recreation and culture" group contributed by +0.18 p.p.. Prices of "Alcoholic beverages and tobacco" by +0.17 p.p.. Prices of "Miscellaneous goods and services" group contributed by +0.16 p.p. "Clothing and footwear" groups contributed by +0.12 p.p.. Prices of "Education service" "group by +0.09 p.p.. Prices of "Health" group contributed by +0.04 p.p.. Price of "Communication" group contributed by +0.03 p.p.. Price of "Transport" group contributed by -0.54 p.p..

Yearly rates of main groups: Compared to October 2022, prices increased the most in the %, "Recreation and culture" by 7.6 %, followed by "Food and non-alcoholic beverage" group by 7.4 %, "Furniture household goods and maintenance" by 5.2 %, "Hotels, coffee-house and restaurants" by 4.8 %, "Alcoholic beverages and tobacco" by 3.6 %, "Clothing and footwear" by 3.2 %, "Education service" and "Miscellaneous goods and services" by 2.9 % each of them, "Housing, water, electricity and other fuel" by 1.6 %, "Health" and "Communication" by 1.1 % each of them. On the other hand, prices of "Transport" group decreased by 8.3 %.

Within the food group prices of "vegetables included potatoes" subgroup signed an increased by 23.4 %, followed by "milk, cheese and eggs" by 8.4 %, "meat" by 7.9 %, "fruits" by 6.1 %, "fish" by 4.5 %, "sugar, jam honey, syrup, chocolates and sweets" by 4.0 %, "bread and cereals" by 1.2 %, etc.

**Monthly rates of main groups:** Compared with September 2023 prices of "Furniture household goods and maintenance" increased by 0.6 %, followed by "Clothing and footwear" by 0.5 %, "Transport" and "Education service" by 0.3 % each of them, "Alcoholic beverages and tobacco" and "Hotels, coffeehouse and restaurants" by 0.2 % each of them.

## **METHODOLOGY**

### - Methodological changes

In January of each year some methodological changes and new developments were carried out in CPI:

- Update of weights: Weights are changed; they are now based on the average expenditure from 2021 Household Budget Survey.
- Update of basket: The list of goods and service content 331 products.
- Update of list of the outlets where the prices are collected is updated.

Started from January 2021, the consumer price index is calculated with the new base period. December 2020 is considered as the base period (December 2020 = 100).

#### - Definitions

The annual rate measures the price change between the current month and the same month of the previous year. This measure is responsive to recent changes in price levels but can be influenced by one-off effect in either month

The monthly rate measures the price change between current month and previous month. Although upto-date it can be affected by seasonal and other effects.

The 12-month average rate compares average Consumer Price Indices and the latest 12 month to the average of the previous 12 months.
