


Producer price Index

Third quarter, 2023

Tirana, on 11 Decembre 2023: In the third quarter 2023, Producer Price Index reached 131.2 compared to 2020. Compared to the third quarter of 2022, the Producer Price Index increased by 5.2 %, a year ago this change was 20.9 %.

Producer Price Index in the third quarter 2023 increased by 0.5 % compared with second quarter 2023.



Annual change: Compared to the third quarter of 2022, the largest price increase of 8.5 % is observed in the "Mining and quarrying" section, followed by the sections "Electricity, gas, steam and air-conditioned" with 6.4 %, "Manufacturing Industry" by 4.4 % and "Water supply, waste treatment and management activities" section with 2.0 %. Within the section "Manufacturing Industry", the largest increase in prices is observed in the activity "Paper printing and regrouping of recorded media" by 19.8 %, followed by the activities "Manufacturing of food products" by 11.7 %, "Manufacture of fabricated metal products except machinery and equipment" with 6.7 %, "Manufacture of furniture" by 6.1 %, "Manufacture of non-metallic mineral products" by 5.9 %, etc. On the other hand, the biggest decrease in prices is observed in the activities "Manufacture of textiles" with 5.4 %, followed by the activities "Manufacture of coke and petroleum products refinery" with 5.1 %, "Manufacture of optics, electronics and computer products" with 1.9 %, "Manufacture of transport vehicles, trailers and semi-trailers" with 1.1 %.

The Index of Production Prices of products for the domestic market: Compared to the third quarter of 2022, the index increased by 7.2 %. The biggest increase in prices is observed in the section "Mining and quarrying" with 13.6 %, followed by the section "Electricity, gas, steam and air conditioning" with 8.6 %, "Manufacturing industry" with 6.7 % and the section "Water supply, waste treatment and management activities" with 0.6 %.

Production Price Index of products for export: Compared to the third quarter of 2022, the index recorded an increase of 1.9 %. The largest increase in prices was recorded in the "Water supply, waste treatment and management activities, waste" section "with 14.0 %, followed by "Manufacturing Industry" section with 1.7 % and "Mining and quarrying" with 0.4 %. On the other side the section "Electricity, gas, steam and air conditioning" decreased with 0.2 %.

Quarterly change: Compared to the second quarter of 2022, the largest increase of 2.1 % is observed in the "Electricity, gas, steam and air conditioning" section, followed by the sections "Mining and quarrying" with 0.8 %, "Water supply, waste treatment and management activities, waste" with 0.1 %. On the other side the section "Manufacturing industry" decreased with 0.4 %. Within this section, the largest decreased in prices is observed in the activities "Manufacture of electrical equipment" with 2.1 %, followed by activities "Manufacture of textiles" with 1.8 %, "Manufacture of leathers and leather products" with 1.1 % etc.

Index of Production Prices of products for the domestic market: Compared to the second quarter of 2023, the index increased by 0.9 %. The biggest increase is observed in the "Electricity, gas, steam and air conditioning" section with 2.9 %, followed by "Mining and quarrying" with 0.9 %, "Manufacturing industry" with 0.2 %, "Water supply, waste treatment and management activities" with 0.1 %

The Index of Production Prices of products for export: Compared to the previous quarter, the index decreased by 0.2 %. The biggest decrease of 0.4 % is observed in the "Manufacturing industry". On the other side the section "Mining and quarrying" increase with 0.6 %, followed by "Water supply, waste treatment and management activities, waste" section with 0.1 %

Methodology

INSTAT calculates Producer Price Index for Domestic Production and Export Price Index. Calculation and publication of Producer Price Index in Albania include:

- Producer Price Index in Total
- Producer Price Index for Domestic Production
- Export Price Index

Producer price index measures the change in the prices of products at the first point of sale after production. Producer Price Index is compatible with Eurostat methodology and covers following economic activities:

- Section B Extracting industry
- Section C Manufacturing industry
- Section D Electric power, water and gas
- Section E Water supply. treatment activities and waste management

These indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA) in 6 – digit level and are published in two digits level. Renovation of the basket of enterprises and products is based on the results of Annual Structural Survey of Enterprises. For calculation of products weights of Producer Price Index for Domestic Production are used data coming from SBS while for calculation of products" weights of Export Price Index are used data coming from Foreign Trade Statistics.

Producer Price Index (PPI) is calculated taking into consideration 2020 as base year (2020 = 100). Calculation's method used in compiling of this index is Laspayer chain – index. It means that each transaction will be compared with its previous year December price (y -1).

Index calculation

For calculation of index is used Laspeyer type and is calculated as following:

- The first part before the equal sign is stating the price level of December 2020 in percent of the average price level during 2020. Hence adjusting the average of 2020 to 100.
- The second term is the chained index movement from December 2020 to December y-1 (a product of yearly index links [short-term links] from December to December).
- The last part is showing the movement from December y-1 to month m year y.

Measures of index

The annual change measures the price change between the current quarter and the same quarter of previous year. This measures is responsive to recent changes in price levels but can be influenced by one – off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
