




Movements of citizens in Albania

December 2023

Tirana, 25 January 2023: The number of foreign citizen arrivals to the territory of Albania in 2023, is 10,155,640 increasing by 34.6 %, compared with 2022. The number of Albanian citizens leaving the territory of Albania during 2023 is 6,913,347 increasing by 17.5 %, compared with the previous year (tab.1).

Arrivals of Albanian and foreign citizens to the territory of Albania, in December 2023 are 1,362,511. Compared to December 2022, this indicator increased by 41.1 %. Albanian and foreign citizen's departures from the territory of Albania during December 2023 are 1,152,429 marking an increase by 7.7 %, compared to the same period of the previous year.

Citizen's arrivals

In December 2023, arrivals of Albanian citizens to the territory of Albania are 745,517. Compared to December 2022, this number increased by 29.9 %.

Arrivals of foreign citizens to the territory of Albania are 616,994. Compared to December 2022, this number increased by 57.6 %.




Fig. 2 Movements of citizens in Albania, December 2022- December 2023

Citizen's departures

Departures of Albanian citizens from the territory of Albania during December 2023 are 602,346. Compared to December 2022, this number decreased by 5.1 %.

Departures of foreign citizens from the territory of Albania during December 2023 are 550,083. Compared to December 2022, this number increased by 26.3 %.

The number of Albanian citizens departures from the territory of Albania during the twelve months of 2023 is 6,913,347 increasing by 17.5 %, compared to the same period a year ago (tab1).

In December 2023, the region with the highest inflows of citizens in Albania is the European region with 571,348 citizens, followed by America and East Asia and Pacific, respectively with 9,845 and 2,617 citizens (tab.2).

In December 2023, compared to December 2022, the arrivals of foreign citizens mark:

- increase, for personal purposes by 58.4 %;
- increase, for vacation purposes, visiting relatives, etc. by 65.1 %;
- increase, for business and professional purposes by 20.4 % (tab. 3).

Methodology

The purpose of the publication for arrivals and departures of Albanian and foreign citizens, by means of transport (sea, air, land and border points), is the measurement of some statistical indicators related to tourism.

Definitions

Arrivals: Include all entries at the border points (by, air, sea and land).

Arrivals is a concept that refers to all entries. A person who visits some countries simultaneously during the reference periode is counted every time as a new entry.

Departures: Includes all exits at the border points. Departures measure the flow of citizens who leave the country of reference. A person who leaves the country of reference several times during the reference periode is always counted as a new exit.

Visitor: For statistical purposes on tourism, the term "visitor" represents a "person who travels in a different place from that in which he resides, in a period shorter than 12 months and major aim of travel in the place visited is a non-profit activity".

The purpose of the trip includes visits of visitors and tourists for:

- Visits for personal purposes grouped as follows:
- 1. Holidays, visit to relatives, etc.;
- 2. Health treatment,
- 3. Religious;
- 4. Tranzit.

Visits for Business category includes all business and professional activities outside the usual environment.

Data Source: Administrative data are provided by the Ministry of Internal Affairs (State Police, Border and Migration Directorate).

Monthly data from January - December 2023 are revised.

The statistical differences between arrivals and departures of Albanian or foreign nationals come mainly from:

- Law No.71 / 2016 "On Border Control", Article 17 "Facilitation of Border Verifications", where during the tourist season or increased inflow, at the moment of entry of citizens at the border, does not register all the incoming citizens;
- The facilitating procedures applied to residents of border areas crossing the border due to their commercial activity, when they cross several times a day, are not registered at the entrance;
- A good share of Albanians hold dual citizenship, who at the time of border crossing July declare different citizenship at exit from it at the entrance, etc.
