3.1. Data description	<ul> <li>Data on Small and Medium Enterprises present to users, statistics on the situation of Small and Medium Enterprises (SMEs), based on the results of the Structural Survey on Enterprises. Structural Business Survey describe the structure, coordination and performance of economic activities, down to detailed activity level. Structural Business Survey aims to provide information on the structure of the economic, financial and main characteristics of active enterprises in the country according to the economic activity and size class of enterprises.</li> <li>Based on Law No. 10042, date 22.12.2008, for some changes and additions in Law No. 8957, date 17.10.2002 "For Small and Medium Enterprises", as amended, the enterprises are classified as: micro, small and medium enterprises.</li> <li>Small and Medium Enterprises are treated for statistical purposes according to the number of employed (measured as employed on a full-time basis), which are classified as follows:</li> <li>Micro enterprises: enterprises with 1 to 9 employed;</li> </ul>

	<ul> <li>Small enterprises: enterprises with 10 to 49 employed.</li> <li>Medium enterprises: enterprises with 50 to 249 employed.</li> </ul>
3.2. Classification system	<ul> <li>The classification used for these statistics is the Statistical Classification of Economic Activities (NACE). The data are produced in national level, broken down by activity grouped in two digits level of this nomenclature. Untill 2012, the data are published using NACE Rev.1.1. Starting from reference year 2013, the data are published in NACE Rev.2. For the reference period 2010-2012, double coding has been carried out in NACE Rev.1.1 and NACE Rev.2. A wide range of statistical classifications is used on the statistics of enterprices.</li> <li>The list of classifications used in production of Structural Business Statistics is:</li> <li>Statistical classification of economic activities NACE Rev.2;</li> <li>Statistical classification of economic activities NACE Rev.1.1;</li> <li>EU recommendation 2003/361 concerning the definition of micro, small and medium-sized enterprises;</li> <li>Law No. 8957, dated on October 17, 2002, "On Small and Medium sized Enterprises";</li> <li>Nomenclature of "Territorial Units for Statistics", NUTS1 and NUTS 2 Enterprises are classified on size classes by number of employed (measured as employed on a full-time basis).</li> </ul>
3.3. Sector coverage	<ul> <li>Structural Business Statistics comprise all active enterprises in Albania of all legal forms. Population consists of all enterprises that according to Statistical Business Register were active in December of the reference year and they exercise their activity in one of the activities covered by Structural Business Survey SBS. Structural Business Statistics cover market enterprises which based on NACE Rev.2 classification, have the main activity in:</li> <li>(B) Mining and quarrying;</li> <li>(C) Manufacturing;</li> <li>(D) Electricity, gas, steam and air conditioning supply;</li> <li>(E) Water supply, sewerage, waste management and remediation activities;</li> <li>(F) Construction;</li> <li>(G) Wholesale and retail trade; repair of motor vehicles and motorcycles;</li> <li>(H) Transport and storage;</li> <li>(I) Accommodation and food service activities;</li> <li>(M) Professional, scientific and technical activitie;</li> <li>(N) Administrative and support services activities;</li> <li>(P) Private education;</li> <li>(Q) Human health and social work activities;</li> <li>(R) Art, entertainment and recreation;</li> </ul>
3.4. Statistical concepts and definitons	<ul> <li>(S) Other service activities (excluding S94).</li> <li>Basic variables.</li> <li>An enterprise is: "The smallest combination of legal units that is an organisational unit producing goods or services which benefits from a certain degree of autonomy in decision-making, especially for the allocation of its</li> </ul>

current resources. An enterprise carries out one or more activities at one or more locations (local unit)". The relationship between an enterprise and a legal unit is therefore defined as: "the enterprise corresponds either to a legal unit or to a combination of legal units".
<b>Employed</b> is defined as the total number of persons who work in the observation unit including proprietors, employees and unpaid family workers.
<b>Turnover</b> comprises the totals amount invoiced by the observation unit during the reference period, and this corresponds to market sales of goods or services supplied to third parties.
<b>Investments</b> during the reference period includes the goods, whether bought from third parties or produced for own use, having a useful life of more than one year including non-produced tangible goods such as land.
Macroeconomic variables.
<b>The production</b> is an activity exercised under the control and responsibility of an institutional unit (enterprise), which combines the sources of labour forces, capital and row materials to produce goods and perform services. The value of production is based on: Incomes from the sale of goods and services (turnover) realized by the enterprise:
<ul> <li>(±) Changes in stocks of work in progress, finished goods and work on contract;</li> <li>(±) Changes in goods and services purchased for resale in the same condition as received;</li> </ul>
<ul> <li>(-) Purchases of goods and services purchased for resale in the same condition as received;</li> <li>(+) Capitalized production;</li> <li>(+) Subsidies.</li> </ul>
<ul> <li>condition as received;</li> <li>(+) Capitalized production;</li> </ul>

Value added at basic prices is calculated as difference between production value and intermediate consumption.

**Exports:** Goods in general are goods destined to be send to a third country subject to customs regime or outside processing arrangements, or re-exported following inside processing.

**Imports:** Goods in general are goods coming from a third country and are directly unloaded or placed to a warehouse according to the customs procedures to accomplish free zones processing, active or customs processing.

Micro and small and medium category (SMEs) include enterprises where are engaged less than 250 employed.

Small enterprise is an enterprise which engages less than 50 employed.

Micro enterprise is an enterprise which engages less than 10 employed.

## 3.5. Statistical unit

Enterprise is both the observation and target unit. National data and data broken

	down by size class of number of persons employed both refer to enterprises.
3.6. Statistical population	<ul> <li>Data are presented for the total business sector by economic activities and by size class of enterprises. Statistics comprise all enterprises that produce goods or services for the market in Albania, for all legal forms (there are not included financial, agricultural and fishing activities). Population consists of all enterprises that according to statistical register were active in December of the reference year. Classification of enterprises is done according to Classification of Economic Activities, NACE Rev.2. Data are collected for calendar year. The fiscal year always corresponds to the calendar year. Enterprises with 1-9 employed are surveyed by sample survey. Enterprises with 10 and more employed are surveyed exhaustively. The data are collected directly from enterprises.</li> <li>The population consist of all enterprises that, according to statistical business register were active in December of the reference year in economic activities covered by Structural Business Survey SBS excluding:</li> <li>Local units;</li> <li>Enterprises with the main activity code (NACE) that are out of scope of SBS survey;</li> </ul>
2.7. D.f.	• Public enterprises in Education (NACE 85) and Health (NACE 86, 87, 88).
3.7. Reference area	Structural Business Survey (SME) comprise all territory of Albania.
3.8. Time coverage	1998 is the first reference year for SBS implementation and the period between 1998 till 2001 was a transitional period for SBS implementation. The data set is more complete and comparable starting from reference year 2002 onwards. Until reference year 2011, data is available in NACE Rev.1.1. Starting with the reference year 2010, data is available in NACE Rev.2.

6.2. Data sharing	Structural Bussines Statistics by size of enterprises have not started yet to be transmitted to EUROSTAT. INSTAT currently completes a series of questionnaires of international organizations regarding the results of the annual structural survey, to European Commission, Enterprise and Industry Directorate-General, OECD, etc.	
7. Confidentiality	7. Confidentiality	
7.1. Confidentiality - policy	The data collected are considered as strictly confidential and used only for statistical purposes and scientific research in accordance with the national Statistical Law No.17/2018 "On Official Statistics", date 10.03.2018 and the Law no. 9887, dated 10.03.2008 "Personal Data Protection", Article 31 of the Law on Official Statistics clearly define that all statistical information collected by INSTAT are confidential and may only be used or published in such summary tables that do not identify the information of the unit. The direct identification is called when a statistical unit is directly identified by the name, address or any officially recognized identification number. When data processing is performed in such a way as to enable the data subject to be identified, the data must be coded immediately so that the entities are no longer recognized.	
7.2. Confidentiality - data treatment	Albanian Institute of Statistics protects and does not disseminate data it has obtained or it has access to, which enable the direct or indirect identification of the statistical units. Albania Institute of Statistics takes all appropriate preventive measures so as to render impossible the identification of individual statistical units by technical or other means that might reasonably be used by a third party. Statistical data that could potentially enable the identification of the statistical unit are disseminated by Albania Institute of Statistics if and only if: a) These data have been treated, as it is specifically set out in the Regulation, in such a way that their dissemination does not prejudice statistical confidentiality

	b) The statistical unit has given its consent, without any reservations, for the disclosure of data.	
	The confidential data that are transmitted to Albania Institute of Statistics are used exclusively for statistical purposes and the only persons who have the right to have access to these data are the personnel engaged in this task. Issues referring to the observance of statistical confidentiality are examined by the staff working in Albania Institute of Statistics. The responsibilities of this staff are to recommend on: which detailed level the statistical data can be disseminated, so as the identification, either directly or indirectly, of the surveyed statistical unit is not possible; the anonymization criteria for the microdata provided to users; the access granting to researchers on confidential data for scientific purposes.

The format of press release has not been changed; it is defined by publication sector as well as the date of release. 10.2. Publications	<ul> <li>The Structural Business Survey SBS results are published in the Statistical Yearbook. Users can find the results on the INSTAT website:</li> <li>Figures;</li> <li>Statistical Yearbook.</li> </ul>
10.3. On-line database	All the information is available in both Albanian and English language. Since 2011, through the Pc-Axis system is provided to external users in web a longer time series data from Structural Business Survey SBS 2002 reference year. 10.4. Micro – data access	The Structural Business Survey SBS data (SME) at micro level are not published due to confidentiality reasons. Aggregated data is the only type of data that is provided to external users. Even the micro data are not published they can be accessed based on the article 34, point 17 of the Low No. 17/2018, "On official statistics".
10.5. Other	Users can submit specific requests for data from the Structural Business Survey SBS survey through a dedicated section for <u>Contacts.</u>
10.6. Documentation on methodology	A short explanation related to the definitions of the main concepts and methodological explanations are provided to users in the end of press releases and publications. Additional support information is given to internal users when needed or required. Also the <u>methodological</u> notes are published at INSTATs website.
10.7. Quality documentation	The Structural Statistic unit document all the work process and procedure for "Small and Medium Enterprises" statistics (SME) for internal purposes.
11. Quality managmen	t
11.1. Quality assurance	INSTAT is committed to ensure the highest quality with respect to the compilation of statistical information. In accordance with the Statistics Law, INSTAT use statistical methods and processes in compliance with internationally recognized scientific principles and standards conduct ongoing analyses of the statistics with a view to quality improvements and ensure that statistics are as up to-date. In performing its tasks it follows the general principles of quality management from the European Statistics Code of Practice. INSTAT declares that it takes into account the following principles: impartiality, quality of processes and products, user orientation, employee orientation, effectiveness of statistical processes, reducing the workload for respondents.
11.2. Quality assessments	Data on Small and Medium Enterprises (SMEs) from Structural Business Survey SBS is compared with previous year's data and checked for any large changes in the data, especially due to large deviations in the main variables concerned. When available the data is checked with an administrative source for confirmation.

12.2. User satisfaction	INSTAT analyzes page views every year and clicks about "Structural Business Statistics" in 2023 are 4,245.
	INSTAT conducts an annual survey to measure <u>User Satisfaction</u> . The 2023 survey results show that the overall quality of the topic "Structural Business Statistics" was rated 3.95 (79,08) on a scale of 1 (very poor) to 5 (very good).
12.3. Completeness	Related to the completeness, the variables and data coming from the survey have been judged as having completeness and analysis in a high quality grade. For being in compliance with European regulation, Small and Medium Enterprises are produced according to the below European Commission (EC), regulations:
	• Regulation (EC) No. 1893/2006 for "Implementation of NACE Rev. 2 in Structural Business Statistics";
	• EU regulation 2019/2152 on European Business Statistics (EBS regulation);

The degree of completeness of the data for "Small and Medium Enterprises", based on <u>Regulation (EU)</u> 2019/2152 on European Business Statistics (EBS Regulation) and methodologies used by Eurostat, is satisfactory.

13. Accuracy and reliability	
13.1. Overall accuracy	<ul> <li>Overall, the data is checked with previous years to identify any significant changes in the data. Such queries are confirmed with financial statements or with an administrative source when available. When these are not available, INSTAT corrects or confirms the data using emails or by calling the respondents. Measures taken by INSTAT each year, to increase response rates or to reduce the impact of nonresponse by imputing them are as follow:</li> <li>Data are collected directly from the enterprise;</li> <li>The information is collected by face-to-face interview from enumerators based on the instructions prepared for this purpose;</li> <li>The enumerators staff is trained how to handle difficult respondents;</li> <li>In Albania, it is not established a system of postal address, so for reducing the number enterprises which are unable to be located, INSTAT stuff and enumerators calls the enterprises;</li> <li>Priority is given to larger businesses. When these enterprises refuses to respond to interviewer, an official request in particular is directed for the president of enterprises and signed by INSTAT director general; it is also done for enterprises that require only this way to give the information;</li> <li>The official request is also sent to other enterprises that agree to respond only if the information is officially requested.</li> <li>The enterprises are invited to contact the Statistical Office in case of questions and always qualified staffs are available to answer the enterprises calls;</li> <li>The large enterprises are rewarded with printed publications of INSTAT.</li> </ul>
13.2. Sampling error	The error due to probability sampling is estimated for more important indicators: Turnover, Employed and Total number of enterprises at section level and total country level. All indicator values are weighted to represent the population.
13.3. Non - sampling error	<ul> <li>Unit non-response takes in consideration enterprises that are unable or unwilling to give the answers, when interviewers are unable to find the enterprises address, when other barriers exist to complete the interview, or when it is not possible to obtain information from other administrative sources about the enterprise.</li> <li>The unit non-response rate for SME 2022 is 15.6%.</li> <li>Over coverage is possible when a unit is registered in the activity under observation, but it actually performs some other activity, which is not the subject of observation.</li> <li>Over coverage rate for SBS 2022 is 2.5%.</li> </ul>

15. Coherence and com	
15.1. Comparability - geographical	<ul> <li>INSTAT uses methodological aspects that are based on concepts and definitions and guidelines of EU Regulation No. 295/2008 concerning SBS statistics and therefore Albanian national SBS statistics could be comparable with EU countries or candidate countries.</li> <li>Related to the reference period, Albania use calendar year which corresponds to the fiscal year.</li> <li>The population consists of all enterprises that, according to statistical business register were active in December of the reference year.</li> <li>The classification of enterprises is done based on Classification of Economic Activities, NACE Rev.2 according to Regulation (EC) No. 1893/2006 for "Implementation of NACE Rev.2 in Structural Business Statistics"; Until now statistical unit in Structural Business Statistics has been enterprise, since it corresponds with legal unit in Albania.</li> </ul>
15.2. Comparability - over time	Due to the implementation of Nace Rev.2, Structural Business Statistics data has a breakdown of time series. Structural Business Survey SBS statistics are provided annually and are comparable from 1998 until 2013. Time series exists since 1998 (as reference year) but the data from year 2002 onwards are more reliable. Based on Nace Rev.1.1 classification the Structural Business Statistics data are comparable from 2002 to 2012, providing a comparability of 11-year time series (CC2=Jlast-Jfirst+1=11). In Nace Rev.2 the Structural Business Statistics data are provided from 2010 onwards, providing a comparability of 13-year time series (CC2=Jlast- Jfirst+1=13). From 2010 onwards are added two new activities (Private health and education) and is excluded fishing. For the other activities, Structural Business Statistics

	data are comparable over the years.
15.3. Coherence - cross domain	Data on Structural Business Statistics can be found in the following related domains: short-term statistics, labour cost statistics, Labour Force Survey (LFS). In these collections data similar to SBS can be found, but it should be noted that methodological differences exist which can explain inconsistencies. Apparent inconsistencies between SBS data and the data from labour cost statistics, labour force survey and short term statistics have been examined. For example the employment statistics in SBS data differs with them of labour force survey due to the methodological aspects used. In LFS are asked persons if they have been occupied in a job for the reference year while in SBS is asked enterprise for the number of persons employed. SBS data are compared with STS data for the "Turnover" variable. This is done regularly to see the tendencies and to have comparable data.
15.4. Coherence - internal	The internal consistency of the data is checked before it is finalised. The links between variables are checked and coherence between different data internal series confirmed.

Review means the continuous completion of data. The accuracy of the published data may increase as a result of the changes made possible by the provision of more complete and qualitative new data, which contribute to the improvement of the preliminary results, published according to the deadlines set in the publication calendar.</li> </ul>

18. Statistical processing		
18.1. Source data	<ul> <li>Survey is the only source of data collection. The basis of the selection is the updated register of enterprises, which were active in December of the reference year. The following are excluded from this register: <ul> <li>Local unit;</li> <li>Enterprises with activities out of scope of SBS coverage;</li> <li>State-owned enterprises in Education (NACE Rev.2 85) and Health (NACE Rev.2 86, 87, 88).</li> </ul> </li> <li>In this way the Frame is created, which has a total of 118,741 enterprises from which a sample with a size of 18,242 enterprises was selected, of which 18,072 enterprises are "Small and Medium Enterprises".</li> <li>The selection method used is "Stratified Systematic Random Sampling (SRS)". Stratification is mainly based on NACE Rev.2, two digits level and on enterprise size (number of employees). Classification of enterprises by activity is done according to the Nomenclature of Economic Activities, NACE Rev.2. The classification of enterprises by size is done according to the number of employed).</li> <li>For enterprises with 1-9 employed, a sample was selected for the survey. Enterprises with 10 or more employed were exhaustively surveyed. The method used to distribute the sample across strata is the "Neyman Allocation" method, in publishing domains.</li> </ul>	
18.2. Frequency of data collection	The data on "Small and Medium Enterprises" are collected on yearly bases through Structural Business Survey SBS.	
18.3. Data collection	The data on Structural Busimess Survey SBS is collected by face to face interview by printed questionnaires. The necessary software and procedures for manual entry are prepared already when preparing for data collection. At that time the procedures and software needed are tested and are done eventual corrections. All data are integrated in a single database after data entry and controls done. Structural Business Survey SBS survey has four questionnaires for four main activities (industry, construction, trade and services). Before conducting survey the subject matters expert specify and analyse which are the needs and requests. Based on the results of those needs and request, it is done	

	the survey design and is prepared all infrastructure needed.
	A crucial phase in preparing for data collection is the preparation of all necessary materials and data entry and processing programs. The enterprises to be interviewed should be identified, the necessary number of interviewers determined, and their selection should have been made. During the organized training for the interviewers on how to conduct the survey, they are also provided with necessary materials such as the questionnaire guide, interviewer's tasks, list of economic activities, product list, notification letter for enterprises, etc. During the data collection process, everything reported by the enterprises is recorded. In case of any uncertainties, the enterprise is contacted again if there is no response, an official letter signed by the head of the institution is sent to the enterprise. Interviewers are required to behave ethically in cases of refusals by the enterprises.
	As regards the level of data, the data editing procedures can broadly be divided into data editing at micro level. In data editing at micro level procedures are implemented at the level of individual units, i.e. at the level of micro data.
18.4. Data validation	1. Data editing in questionnaire.

	For the untreated part the re-weighing method is used. Programs in SAS Software, Macro Clan are used for re-weighing and data estimation. The estimation is done according to the traditional Horvitz- Thompson method (also known as the $\pi$ evaluator), which is applied from the design stage of SRS.
