

# **Building permits issued**

### Fourth quarter, 2024

**Tirana, 28 February 2025:** In the fourth quarter 2024 are approved 317 building permits issued for new buildings, from 303 building permits issued approved in the fourth quarter 2023, increasing this indicator by 4.6 % (tab.2).


Building permits issued total area for new buildings in the fourth quarter 2024 is 482,854 m<sup>2</sup>, from 592,660 m<sup>2</sup> approved in the fourth quarter 2023, decreasing this indicator by 18.5 % (tab.3).

The approximate value of building permits issued for buildings and civil engineering works, in the fourth quarter 2024, is 25,8 billion ALL, from 25,3 billion ALL approved in the fourth quarter 2023, increased by 1.8 % (tab.4).

During 2024, the total number of building permits issued for new buildings approved is 1,336 from 1,602 building permits issued approved in 2023, increasing this indicator by 16.6 %.

The total area of building permits for new buildings approved is 2,498,916 m<sup>2</sup>, from 2,115,819 m<sup>2</sup> approved in 2023, increasing this indicator by 18.1 %. The approximate value of building permits issued for buildings and civil engineering works is 106,4 billion ALL in 2024, from 89,6 billion ALL approved in 2023, increasing this indicator by 18.8 %.

## Methodology

"Building permits issued" is a publication with quarterly frequency, which the main objective is to present information on building permits issued for buildings and civil engineering works on prefecture and national level. The statistical information about building permits issued is a short-term indicator for the future development of the construction sector.

The main statistical indicators presented in this publication are:

- Number of building permits issued for new buildings
- Total area of building permits issued for new buildings
- Approximate value of building permits issued for buildings and civil engineering works

The data on building permits issued is an administrative data. The statistical information on building permits issued is collected by INSTAT regional statistical offices in cooperation with the urbanization offices of municipalities.

#### **Definitions**

**Building permits issued** is an authorization to start work on a building project. The building permit is the final stage of planning and building authorization prior to start the work.

**Buildings** are roofed constructions which can be used separately, have been built for permanent purposes, can be entered for persons and are suitable or intended for protecting persons, animals or objects. The buildings are classified in two different kinds of categories: 1) Residential buildings; 2) Non residential buildings, where are included hotels and similar, office buildings, wholesale and retail trade buildings, industrial buildings and other buildings.

**Building permits total area** is compiled from the square metres of useful floor area of new residential and non residential buildings for which permits have been granted. The useful floor area of a building is measured within its external walls, excluding: 1) construction areas (e.g. areas of demarcation components, supports, columns, pillars, shafts, chimneys); 2) functional areas for ancillary use (e.g. areas occupied by heating and air-conditioning installations, or by power generators); 3) thoroughfares (e.g. areas of stairwells, lifts, escalators).

**Civil Engineering Works** are all constructions not classified under buildings: railways, roads, bridges, highways, pipelines, telecommunication and electricity lines, etc.

**Client** is the person or structure which realize the construction.

#### Source of data

Administrative source, the statistical information on Building permits issued is collected by INSTAT regional statistical offices in cooperation with the respective municipalities.
