# **Producer price Index**

**Tirana. 05 March 2014:** In the fourth quarter 2014, Producer Price Index reached 102.0 % compared with base year 2010. (2010 = 100).

**The annual change of index is -**1.3 %. Lowest prices are signed in "Mining and quarrying" section by 5.6 % and "Manufacturing" section by 0.7 %.


Compared with the same period of year 2013, prices of products produced for export increased by 0.3 %, while prices of products produced and sold on domestic market decreased by 2.1 %.

**Quarterly change of index is -1.1 %.** Producer Prices in" Mining and quarrying" decreased by 5.6 %. Lowest prices are recorded on extraction of crude petroleum and natural gas products, by 7.9 %.

Producer Price Index decreased by 0.1 % in "Manufacturing" section. The prices decreased in manufacture of leather products by 1.9 %, manufacture of tobacco products by 1.7 % and manufacture of coke and petroleum products refinery by 1.0 %. While product prices of "Manufacture of food products" and "Metallurgy" increased respectively by 0.8 % and 1.4 %.

**Producer Price Index for Domestic** market reached 100.7 % signing a decrease by 1.7 % compared with third quarter 2014 (2010 = 100). Lower prices are recorded in "Mining and quarrying" section by 6.1 % and "Manufacturing" section by 0.8 %.

**Export Price Index** reached 104.5 % signing an increase by 0.3 % compared with the previous quarter. Export price index increased by 0.5 % in "Manufacturing" section. Here we can mention the increase price of food production by 0.8 %.

# Metodology

# **User information**

INSTAT in the wake of its efforts to calculate and publish statistical indicators, publishes the Producer Price Index, fourth quarter 2014 based on Nomenclature of Economic Activities, NACE Rev.2. The application of the Nomenclature of economic activities NACE Rev. 2 is based on the legal act approved through the Decreed of the Council of Ministers N°320, date 20. 05. 2014.

In the contexts of standardizing and approaching the Short term statistics indicators to the standards of EU statistics, INSTAT has revised the reference period of the Producer price Index from 2005 = 100 to 2010 = 100.

The process of passing of statistical units from NACE Rev. 1.1 to NACE Rev. 2 is performed through the construction of a converted matrix, based on the statistical information obtained from the Structural Business Survey of Enterprises 2010, 2011,2012.

Producer price index measures the change in the prices of products at the first point of sale after production. Producer Price Index is compatible with Eurostat methodology and covers following economic activities:

- Extracting industry, B
- Manufacturing industry, C
- Electric power, water and gas, D
- Water supply, treatment activities and waste management

INSTAT calculates Producer Price Index for Domestic Production and Export Price Index. Calculation and publication of Producer Price Index in Albania include:

- Producer Price Index in Total
- Producer Price Index for Domestic Production
- Export Price Index

Producer Price Index

These indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA) in 6 – digit level and are published in two digit level. Renovation of the basket of enterprises and products is based on the results of Annual Structural Survey of Enterprises. For calculation of products 'weights of Producer Price Index for Domestic Production are used data coming from SBS while for calculation of products' weights of enterprises are used data coming from Foreign Trade Statistics.

Producer Price Index (PPI) is calculated taking into consideration 2010 as base year (2010 = 100). Calculation's method used in compiling of this index is Laspayer chain – index. It means that each transaction will be compared with its previous year December price (y -1).

#### Index calculation

For calculation of index is used Laspeyer type and is calculated as following:

- The first part before the equal sign is stating the price level of December 2004 in percent of the average price level during 2010, hence adjusting the average of 2010 to 100.
- The second term is the chained index movement from December 2004 to December y-1 (a product of yearly index links [short-term links] from December to December).
- The last part is showing the movement from December y-1 to month m year y.

#### Measures of index

The annual change measures the price change between the current quarter and the same quarter of

previous year. This measures is responsive to recent changes in price levels but can be influenced by one -

off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
