## **Producer Price Index**

**Tirana. 07 March 2015:** In the fourth quarter 2015, Producer Price Index reached 99.6 % compared with base year 2010. (2010 = 100).

**The annual change of index is -2.3** %. Lowest prices are signed in products produced in "Mining and quarrying" section by 9.5 %. Here we can mention the decrease price of products on "Extraction of crude petroleum and natural gas" 15.3%.

Producer prices on activities of manufacturing sections increased by 0.3 % referred to the same period of 2014. Here we can mention the increase price of chemical products by 5.6 %, dressing products by 2.7 %, machinery and equipments products, by 5.1%.

The index price decreased on "Manufacture of coke and petroleum products refinery" activity, by 3.1 %.

Compared with the same period of year 2014, prices of products produced and sold on domestic market decreased by 2.3 %. Here we can mention the decrease prices in sections of "Mining and quarrying" by 12.2%.

Index prices of products produced for export decreased by 2.2 % compared with the same period of previous year.

**Quarterly change of index is -0.4 %.** Producer Prices in" Mining and quarrying" decreased by 0.8 %. Lower prices are recorded on extraction of crude petroleum and natural gas products, by 3.2 %.

Producer Price Index in "Manufacturing" section is not changed compared with the previous quarter. Despite of in section level there are not signed changes of the index within it there are mentioned increases and decreases of producer prices in different activities. The prices increased in manufacture of food by 0.1 % and metallurgy products by 1.5 %.

Prices of products decreased in "Manufacture of textile" activity by 0.3 % and "Manufacture of non-metallic mineral products" activity by 0.9 %.

Index price of section "Water supply, treatment activities and waste management" decreased 3.4 % compared with previous quarter. Here we can mention the decrease price of products in activities of collection, treatment and disposal of waste, materials recovery by 7.5 %.

#### 04/12/2015

**Producer Price Index for Domestic** market reached 98.3 % signing an increase by 0.1 % compared with third quarter 2015. Higher prices are recorded in "Mining and quarrying" section by 2.0 %. Producer prices of "Manufacturing" section decreased by 0.3 %.

**Export Price Index** reached 102.2 % signing a decrease by 1.0 % compared with the previous quarter. Here we can mention the decrease of export price products in section "Mining and quarrying" by 2.6 %. The export price products increased in section "Manufacturing" by 0.3 %.




Fig. 1 Monthly Producer Price Index, January 2014 – December 2015

# Metodology

Producer price index measures the change in the prices of products at the first point of sale after production. Producer Price Index is compatible with Eurostat methodology and covers following economic activities:

- Extracting industry, B
- Manufacturing industry, C
- Electric power, water and gas, D
- Water supply, treatment activities and waste management

INSTAT calculates Producer Price Index for Domestic Production and Export Price Index. Calculation and publication of Producer Price Index in Albania include:

- Producer Price Index in Total
- Producer Price Index for Domestic Production
- Export Price Index

These indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA) in 6 – digit level and are published in two digit level. Renovation of the basket of enterprises and products is based on the results of Annual Structural Survey of Enterprises. For calculation of products 'weights of Producer Price Index for Domestic Production are used data coming from SBS while for calculation of products' weights of products' weights of Export Price Index are used data coming from Foreign Trade Statistics.

Producer Price Index (PPI) is calculated taking into consideration 2010 as base year (2010 = 100). Calculation's method used in compiling of this index is Laspayer chain – index. It means that each transaction will be compared with its previous year December price (y -1).

#### Index calculation

For calculation of index is used Laspeyer type and is calculated as following:

- The first part before the equal sign is stating the price level of December 2009 in percent of the average price level during 2010, hence adjusting the average of 2010 to 100.
- The second term is the chained index movement from December 2010 to December y-1 (a product of yearly index links [short-term links] from December to December).
- The last part is showing the movement from December y-1 to month m year y.

#### Measures of index

**The annual change measures** the price change between the current quarter and the same quarter of previous year. This measures is responsive to recent changes in price levels but can be influenced by one – off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
