# **Producer price Index**

### Third quarter, 2016

**Tirana. 06 December 2016:** In the third quarter 2016, Producer Price Index reached 99.1 % compared with base year 2010. (2010 = 100).




Fig. 1 Monthly Producer Price Index, January 2015 - September 2016

**The annual change of index is – 0.8** %. Lowest prices are signed in products produced in "Manufacturing" section by 1.0 %. Here we can mention the decrease price of products on manufacture of textile by 5.8 %, manufacture of leathers and leather products by 2.3 %, manufacture of dressing and wearing apparel by 0.2 %. While producer prices on "Paper printing and regrouping of recorded media" activity and "Manufacture of papers and paper products" activity, signed an increase by 2.2% and 0.7 % respectively.

Producer prices on activities of "Mining and quarrying" section increased by 0.4 % referred to the same period of 2015. Here we can mention the increase price on mining of metal ores products by 3.4 %. Producer prices in manufacture of extraction of crude petroleum and natural gas products decreased by 0.9 %.

Compared with the same period of year 2015, prices of products produced and sold on domestic market increased by 0.7

Index prices of products produced for export decreased by 2.9 % compared with the same period of previous year. The highest decrease price is signed in export price of "Extraction of crude petroleum and natural gas; auxiliary services" by 11.7 %.

**Quarterly change of index is -0.6 %.** Producer Prices in Mining and quarrying decreased by 1.3 %. Lowest prices are recorded on extraction of crude petroleum and natural gas products, by 1.9 %.

Producer Price Index in "Manufacturing" section decreased by 0.6 % compared with the previous quarter. Here we can mention the decrease price of manufacture of textile by 2.1 %, metallurgy of metals by 2.0 %, manufacture of leathers and leather products by 1.0 %. While producer prices on manufacture of food products doesn't change compared with previous quarter.

**Producer Price Index for Domestic** market reached 98.9 % signing an decrease by 0.4 % compared with second quarter 2016. Lowest prices are recorded in "Mining and quarrying" section by 2.4 %. Producer prices of "Manufacturing" section decreased by 0.3 %.

**Export Price Index** reached 100.2 % signing a decrease by 1.0 % compared with the previous quarter. Here we can mention the decrease of export price products in sections: "Mining and quarrying" and "Manufacturing" by 0.9 % respectively.

# Metodology

Producer price index measures the change in the prices of products at the first point of sale after production. Producer Price Index is compatible with Eurostat methodology and covers following economic activities:

- Extracting industry. B
- Manufacturing industry. C
- Electric power. water and gas. D
- Water supply. treatment activities and waste management

INSTAT calculates Producer Price Index for Domestic Production and Export Price Index. Calculation and publication of Producer Price Index in Albania include:

- Producer Price Index in Total
- Producer Price Index for Domestic Production
- Export Price Index

These indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA) in 6 – digit level and are published in two digit level. Renovation of the basket of enterprises and products is based on the results of Annual Structural Survey of Enterprises. For calculation of products 'weights of Producer Price Index for Domestic Production are used data coming from SBS while for calculation of products' weights of Export Price Index are used data coming from Foreign Trade Statistics.

Producer Price Index (PPI) is calculated taking into consideration 2010 as base year (2010 = 100). Calculation's method used in compiling of this index is Laspayer chain – index. It means that each transaction will be compared with its previous year December price (y -1).

#### Index calculation

For calculation of index is used Laspeyer type and is calculated as following:

- The first part before the equal sign is stating the price level of December 2009 in percent of the average price level during 2010. hence adjusting the average of 2010 to 100.
- The second term is the chained index movement from December 2010 to December y-1 (a product of yearly index links [short-term links] from December to December).
- The last part is showing the movement from December y-1 to month m year y.

#### Measures of index

The annual change measures the price change between the current quarter and the same quarter of previous year. This measures is responsive to recent changes in price levels but can be influenced by one – off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
