External Trade

January, 2014


Tirana, February 28, 2014: On January 2014 the value of exports was 18 billion lekë, decreasing by 1.5 % comparing with January 2013 and decresing by 16.6% comparing with December 2013. The main group of goods increasing, compared with January 2013, were: "Leather and leather manufacture" by 19.8 %, "Minerals, fuels, electricity" by 17.8 %, and "Construction materials and metals" by 11.5 %. Export of group "Wood manufactures and article of paper" increased by 48.4 % and "Food, beverages, tobacco" increased by 22.2%, compared with the same period of previous year.

On January 2014 the value of imports was 34 billion leke, increasing by 0.9 % compared with January 2013 and decresing by 39.4 % comparing with December 2013 . The main group of goods increasing, compared with January 2013, were: "Wood manufactures and article of paper" by 32.8 %, "Leather and leather manufacture" by 26.8 % and "Textile and footwear" by 20.4 %. Import of groups: "Minerals, fuels, electricity" decreased by 8.9 % and "Construction materials and metals" decreased by 4.6 %, compared with the same period of previous year.

This month the trade deficit is 17 billion leke signing an increase by 3.6 % compared with January 2013 and a decrease by 53.1% compared with December 2013.

Trade with the EU countries is 67.3 % of total trade. The main trade partners remain Italy (42.2%), Greece (6.5%), China (5.6%) and Turkey (4.9%).

Definitions

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

F.O.B. (Free on board): Delivery term, indicating that he price of the goods includes transport and handling costs to an agreed port of loading.

Imports are goods arrived from a third country and ar directly placed, or are left in warehouse, under customs procedure of release for free circulation, inw rd processing or processing under customs control.

C.I.F. (Cost, Insurance, Freight): Delivery term indic ting that the price of the goods includes insurance and freight to an agreed port of destination.

Harmonized system (HS) The Harmonized System (HS) i a goods nomenclature used by foreign trade statistics and for customs tariffs.

The HS comprises about 5,000 separate groups of goods, identified by a 4-digit code (heading) or a 6-digit code (subheading) in 21 sections and 96 chapters.
