Foreign Trade

May, 2014

Tirana, June 30, 2014: On May 2014 the value of exports was 25 billion lekë, increasing by 8.7 % comparing with May 2013 and 11 % comparing with April 2014. The main groups of goods increasing, compare with the same period of the previous year, were: "Construction materials and metals" by 58.7 %, "Textile and footwear" by 24 % and "Chemical and plastical products" by 19.6 %. Export of group "Minerals, fuels and electricity" decreased by 12.6 %, compare with the same period of the previous year.

On May 2014 the value of imports was 48 billion lekë, increasing by 6.7 % compared with May 2013 and 8.7 % compared with April 2014. The main groups of goods increasing, compare with the same period of the previous year, were: "Leather and leather manufactures" by 31.8 %, "Machinery, equipment and metals" by 15.7 % and "Construction materials and metals" by 14.8 %. Import of group: "Chemical and plastical products" decreased by 10.3 %, compare with the same period of the previous year.

This month the trade deficit is 23 billion lekë signing an increase by 4.5 % compared with May 2013 and 6.2 % compared with April 2014.

Trade with the EU countries is 63.6 % of total trade. The main trade partners remain Italy (34.1 %), Greece (8.5 %), Turkey (8.1 %) and China (6.8 %).




Chart. 1 Flow of goods in external trade, April 2013 – May 2014 (billion lekë)

DEFINITIONS

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

F.O.B. (Free on board): Delivery term, indicating that the price of the goods includes transport and handling costs to an agreed port of loading.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

C.I.F. (Cost, Insurance, Freight): Delivery term indicating that the price of the goods includes insurance and freight to an agreed port of destination.

Harmonized system (HS) The Harmonized System (HS) is a goods nomenclature used by foreign trade statistics and for customs tariffs.

The HS comprises about 5,000 separate groups of goods, identified by a 4-digit code (heading) or a 6digit code (subheading) in 21 sections and 96 chapters.
