External Trade


Tirana, August 28, 2014: On July 2014 the value of exports was 23 billion lekë, decreasing by 5.7 % comparing with July 2013 and increasing 1.9% comparing with June 2014. The main groups of goods decreasing, compare with the same period of the previous year, were: "Machineries, equipments and spare parts" by 32.1 %, "Minerals, fuels, electricity" by 25% and "Wood manufactures and articles of paper" by 19.3%. Export of group: "Construction materials and metals" increased by 17.3 %, compare with the same period of the previous year.

On July 2014 the value of imports was 47 billion lekë, decreasing by 2.8% compared with July 2013 and 4.7% compared with June 2014. The main groups of goods decreasing, compare with the same period of the previous year, were: "Minerals, fuels, electricity" by 18.3%, "Construction materials and metals" by 13.4% and "Chemical and plastical product by 5.7%. Import of group: "Leather and leather manufactures" increased by 32.7%, compare with the same period of the previous year.

This month the trade deficit is 24 billion lekë signing an increase by 0.1% compared with July 2013 and decreasing 10.2% compared with June 2014.

Trade with the EU countries is 68.7% of total trade. The main trade partners remain Italy (37.8%), Greece (7.2%), China (7.1%) and Turkey (5.8%).

DEFINITIONS

Exports are goods destined to a third country, placed under customs export or outward processing

arrangements or re-exported following inward processing.

F.O.B. (Free on board): Delivery term, indicating that the price of the goods includes transport and

handling costs to an agreed port of loading.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under

customs procedure of release for free circulation, inward processing or processing under customs

control.

C.I.F. (Cost, Insurance, Freight): Delivery term indicating that the price of the goods includes insurance

and freight to an agreed port of destination.

Harmonized system (HS) The Harmonized System (HS) is a goods nomenclature used by foreign trade

statistics and for customs tariffs.

The HS comprises about 5,000 separate groups of goods, identified by a 4-digit code (heading) or a 6-

digit code (subheading) in 21 sections and 96 chapters.
