External Trade



Tirana, September 29, 2014: On August 2014 the value of exports was 19 billion lekë, increasing by 2.3 % comparing with August 2013 and decreasing 18.9 % comparing with July 2014. The main groups of goods increasing, compare with the same period of the previous year, were: "Machineries, equipments and spare parts" by 34.0 %, "Textile and footwear" by 23.6 % and "Construction materials and metals" by 20.6 %. Export of group: "Minerals, fuels, electricity" decreased by 15.5 %, compare with the same period of the previous year.

On August 2014 the value of imports was 45 billion lekë, increasing by 5.1% compared with August 2013 and decreased 5.5% compared with July 2014. The main groups of goods increasing, compare with the same period of the previous year, were: "Leather and leather manufactures" by 29.9%, "Textile and footwear" by 12.8% and "Minerals, fuels, electricity" by 12.5%. Import of group: "Wood manufactures and articles of paper" decreased by 13.5%, compare with the same period of the previous year. This month the trade deficit is 26 billion lekë signing an increase by 7.1% compared with August 2013 and decreasing 7.2% compared with July 2014.

Trade with the EU countries is 64.2% of total trade. The main trade partners remain Italy (29.5 %), Greece (9.3 %), China (6.7 %) and Germany (6.7 %).

DEFINITIONS

Exports are goods destined to a third country, placed under customs export or outward processing

arrangements or re-exported following inward processing.

F.O.B. (Free on board): Delivery term, indicating that the price of the goods includes transport and

handling costs to an agreed port of loading.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under

customs procedure of release for free circulation, inward processing or processing under customs

control.

C.I.F. (Cost, Insurance, Freight): Delivery term indicating that the price of the goods includes insurance

and freight to an agreed port of destination.

Harmonized system (HS) The Harmonized System (HS) is a goods nomenclature used by foreign trade

statistics and for customs tariffs.

The HS comprises about 5,000 separate groups of goods, identified by a 4-digit code (heading) or a 6-

digit code (subheading) in 21 sections and 96 chapters.
