## **External Trade**

## December, 2014

**Tirana, January 28, 2015:** On December 2014 the value of exports was 19 billion lekë, decreasing by 10.5 % comparing with December 2013 and 10.4 % comparing with November 2014. The main group of goods decreasing compare with the same period of the previous year, were: "Minerals, fuels, electricity" by 29.6 %, "Construction materials and metals" by 26.1 % and "Wood manufactures and article of paper" by 19.9 %. Exports of groups: "Machineries, equipments and spare parts", "Chemical and plastical products" and "Leather and leather manufactures" increased respectively by 89.7 %, 30.9 % and 28.7 % compare with the same period of the previous year.

On December 2014 the value of imports was 54 billion lekë, decreasing by 8.8 % compared with December 2013 and increasing by 12.0 % compared with November 2014. The main groups of goods decreasing compare with the same period of the previous year, were: "Minerals, fuels, electricity" by 29.9 %, "Machineries, equipments and spare parts" by 20.5 % and "Food, beverages, tobacco" by 10.9 %. Imports of groups: "Wood manufacturies and article of paper", "Chemical and plastical products" and "Construction materials and metals" increased respectively by 21.7 %, 17.7 % and 9.8 %, compare with the same period of the previous year.

This month the trade deficit is 35 billion lekë signing an decrease by 7.9 % compared with December 2013 and increasing 29.8 % compared with November 2014.

Trade with the EU countries is 65.1 % of total trade. The main trade partners remain Italy (35.9 %), Turkey (7.0 %), China (6.8 %) and Greece (6.5 %).




Fig. 1 Flow of goods in external trade, November 2013 – December 2014 (billionALL)



Fig.3 Export - Foreign trade by group of goods (Billion ALL)





Fig.4 Import - Foreign trade by group of goods (Billion ALL)

**DEFINITIONS** 

Exports are goods destined to a third country, placed under customs export or outward processing

arrangements or re-exported following inward processing.

F.O.B. (Free on board): Delivery term, indicating that the price of the goods includes transport and

handling costs to an agreed port of loading.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under

customs procedure of release for free circulation, inward processing or processing under customs

control.

C.I.F. (Cost, Insurance, Freight): Delivery term indicating that the price of the goods includes insurance

and freight to an agreed port of destination.

Harmonized system (HS) The Harmonized System (HS) is a goods nomenclature used by foreign trade

statistics and for customs tariffs.

The HS comprises about 5,000 separate groups of goods, identified by a 4-digit code (heading) or a 6-

digit code (subheading) in 21 sections and 96 chapters.
