External Trade

November, 2014


Tirana, December 28, 2014: On November 2014 the value of exports was 21 billion lekë, increasing by 1.2 % comparing with November 2013 and decreasing 4.6 % comparing with October 2014. The main group of goods increasing compare with the same period of the previous year, were: "Machineries, equipments and spare parts" by 30.9 %, "Food, beverages, tobacco" by 26.0 % and "Textile and footwear" by 14.6 %. Exports of group: "Leather and leather manufactures" decreased by 24.3 %, compare with the same period of the previous year.

On November 2014 the value of imports was 48 billion lekë, increasing by 6.1 % compared with November 2013 and decreasing by 9.1 % compared with October 2014. The main groups of goods increasing compare with the same period of the previous year were: "Construction materials and metals" by 26.0 % "Wood manufacturies and article of paper" by 20.0 % and "Machineries, equipments and spare parts" by 13.1 %. Imports of group: "Minerals, fuels, electricity" decreased by 10.7 %, compare with the same period of the previous year.

This month the trade deficit is 26 billion lekë signing an increase by 10.5 % compared with November 2013 and decreasing 12.5 % compared with October 2014.

Trade with the EU countries is 65.3 % of total trade. The main trade partners remain Italy (37.7 %), Greece (6.8 %), China (6.4 %) and Turkey (6.0 %).

DEFINITIONS

Exports are goods destined to a third country, placed under customs export or outward processing

arrangements or re-exported following inward processing.

F.O.B. (Free on board): Delivery term, indicating that the price of the goods includes transport and

handling costs to an agreed port of loading.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under

customs procedure of release for free circulation, inward processing or processing under customs

control.

C.I.F. (Cost, Insurance, Freight): Delivery term indicating that the price of the goods includes insurance

and freight to an agreed port of destination.

Harmonized system (HS) The Harmonized System (HS) is a goods nomenclature used by foreign trade

statistics and for customs tariffs.

The HS comprises about 5,000 separate groups of goods, identified by a 4-digit code (heading) or a 6-

digit code (subheading) in 21 sections and 96 chapters.
