

# **International Trade in Goods**

## **April, 2015**

**Tirana, May 28, 2015:** On April 2015 the value of exports was 20 billion lekë, decreasing by 10.0 % compared with April 2014 and 7.8 % compared with March 2015. On April 2015 the value of imports was 43 billion lekë, decreasing by 2.0 % compared with April 2014 and 2.2 % compared with March 2015. This month the trade deficit is 23 billion lekë signing an increase by 6.5 % compared with April 2014 and 3.3 % compared with March 2015.

Trade with the EU countries is 64.7 % of total trade. The main trade partners remain Italy (36.0 %), Greece (7.9 %), Turkey (6.6 %) and China (6.6 %),


On April 2015 exports to EU countries decreased by 25.3 %, compared with previous year, occuping 66.9 % of total export. Partner with the largest weight in exports to EU countries is Italy that occupies 67.9 %, Spain with 6.3 % and Greece with 5.6 % of total export. EU countries with which Albania has had the highest increase of exports, compared with April 2014 are: Austria, United Kingdom and Germany. While, countries with which has had a decrease of exports are: Spain, Croatia and Italy.

Exports to Kosovo and China, in April 2015, compared with previous year, increased occuping respectively 13.4 % and 4.0 % of total export, while exports to Turkey decreased occuping 2.7 % of total export.

On April 2015 imports from EU countries increased by 3.7 %, compared with April 2014, occuping 63.6 % of total import. Partner with the largest weight in imports from EU countries is Italy that occupies 49.6 %, Greece with 15.5 % and Germany with 9.5 %. EU countries with which Albania has had the highest increase of imports, compared with April 2014 are: Spain and Italy. While, countries with which has had a decrease of exports are: Greece, Austria and United Kingdom.

Imports from Turkey and China, in April 2015, compared with previous year, increased occuping respectively 8.5 % and 7.8 % of total import, while imports from Kosovo decreased occuping 1.2 % of total import.


Fig.2 ForeignTrade in Goods by EU countries, April 2015



#### The influence of the main groups in the annual change in exports:

Annual decrease in April 2015 is influenced by groups: "Machinery, equipment, spare parts" contributed with +1.6 percentage point, "Food, beverages, tobacco" contributed with +1.0 percentage point, "Chemical and plastical products" contributed with +0.1 percentage point, "Minerals, fuels, electricity" contributed with -8.5 percentage point, "Textile and footwear" contributed with -3.8 percentage point.


Fig.3 Annual impact of groups in exports



## The influence of the main groups in the annual change in imports:

Annual decrease in April 2015 is influenced by groups: "Machinery, equipment, spare parts" contributed with +1.9 percentage point, "Textile and footwear" contributed with +1.1 percentage point, "Food, beverages, tobacco" contributed with +0.5 percentage point, "Minerals, fuels, electricity" contributed with -4.4 percentage point, "Construction materials and metals" contributed with -1.3 percentage point.

# **DEFINITIONS**

April, 2015

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to a resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
