


Foreign Trade in Goods

August, 2015


Tirana, August 28, 2015: On August 2015 the value of exports was 15 billion lekë, decreasing by 17.6 % compared with August 2014 and 32.1 % compared with July 2015. The value of imports in August 2015, was 40 billion lekë, decreasing by 10.3 % compared with August 2014 and 23.6 % compared with July 2015. This month the trade deficit is 25 billion lekë signing an decrease by 5.0 % compared with August 2014 and 17.2 % compared with July 2015.


Fig.1 Flow of goods, July2014– August 2015 (billionALL)



The influence of the main groups in the annual change in exports:

Annual decrease of exports by 17.6 % this month is influenced by groups: "Minerals, fuels, electricity" contributed with -17.3 percentage point, "Construction materials and metals" contributed with -2.7 percentage point, "Leather and leather manufacture" contributed with -0.4 percentage point. In the annual change of exports a positive contribution was given by the groups: "Food, beverages, tobacco" contributed with +2.1 percentage point, "Textile and footwear" contributed with +0.9 percentage point, "Chemical and plastical products" contributed with +0.05 percentage point






The influence of the main groups in the annual change in imports:

Annual decrease by 10.3 % in August 2015 is influenced by groups: "Minerals, fuels, electricity" contributed with -8.0 percentage point, "Construction materials and metals" contributed with -2.0 percentage point, "Chemical and plastical products" contributed with -1.4 percentage point. In the annual change of imports a positive contribution was given by the groups: "Textile and footwear" contributed with +0.9 percentage point, "Food, beverages, tobacco" contributed with +0.7 percentage point.


Fig.3 Annual impact of groups in imports



In August 2015, countries with which Albania has had the highest increase of exports, compared to August 2014 are: Italy with 3.6 %, Kosovo with 4.1 and Macedonia 10.9 %. While, countries with which has had a decrease of exports are: Spain with 7.4 %, Germany with 49.5 % and Greece with 0.6 %.

In August 2015, countries with which Albania has had the highest increase of imports, compared to August 2014 are: Turkey with 26.2 %, Russia with 9.7 %, and Croatia with 114.6 %. While, countries with which has had a decrease of imports are: Italy with 7.7 %, Greece with 35.9 % and China with 7.7 %.

Trade with the EU countries is 63.0 % of total trade. In August 2015, exports to EU countries occuped 75.1 % of total export and imports from EU countries occuped 58.3 % of total import.

The main trade partners remain Italy (32.6 %), Greece (7.2 %) Turkey (6.6 %) and China (6.6 %).

DEFINITIONS

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to a resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
