Foreign Trade in Goods

December, 2015

Tirana, January 28, 2016: On December 2015 the value of exports was 18 billion lekë, decreasing by 7.7 % compared with December 2014 and 8.5 % compared with November 2015. The value of imports in December 2015, was 53 billion lekë, decreasing by 2.2 % compared with December 2014 and increasing by 8.0 % compared with November 2015. This month the trade deficit is 35 billion lekë signing an increase by 0.9 % compared with December 2014 and 18.9 % compared with November 2015.




Fig.1 Flow of goods, November 2014– December 2015 (billionALL)

The influence of the main groups in the annual change in exports:

In annual decrease of exports by 7.7 % this month a negative contribution was given by the groups: "Minerals, fuels, electricity" with -9.8 percentage point, "Construction materials and metals" with -5.0 percentage point, "Machinery, equipment spare parts" with -1.2 percentage point. While a positive contribution was given by the groups: "Textile and footwear" with +4.8 percentage point, "Food, beverages, tobacco" with +2.7 percentage point, "Leather and leather manufacture" with +0.3 percentage point.




Fig.2 Annual impact of groups in exports

The influence of the main groups in the annual change in imports:

In annual decrease of imports by 2.2 % in December 2015 a negative contribution was given by the groups: "Minerals, fuels, electricity" with -4.1 percentage point, "Construction materials and metals" with -1.3 percentage point and "Machinery, equipment spare parts" with -0.6 percentage point. While a positive contribution was given by the groups: "Textile and footwear" with +2.3 percentage point, "Food, beverages, tobacco" with +0.5 percentage point and "Chemical and plastical products" with +0.5 percentage point.





Fig.3 Annual impact of groups in imports

In December 2015, countries with which Albania has had the highest increase of exports, compared to December 2014 are: Italy with 7.9 %, Spain with 26.3 % and Greece with 32.2 %. While, countries with which has had a decrease of exports are: Kosovo with 29.6 %, Germany with 11.9 % and China with 25.4 %.

In December 2015, countries with which Albania has had the highest increase of imports, compared to December 2014 are: Turkey with 22.9 %, China with 5.5 % and Germany with 30.0 %. While, countries with which has had a decrease of imports are: Italy with 4.9 %, Greece with 10.2 % and Spain with 45.9 %.

Trade with the EU countries is 66.6 % of total trade. In December 2015, exports to EU countries occuped 80.3 % of total export and imports from EU countries occuped 62.0 % of total import. The main trade partners remain Italy (36.9 %), Turkey (7.4 %), China (7.2%) and Germany (7.0 %).

DEFINITIONS

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to a resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
