


Foreign Trade in Goods

February, 2015

Tirana, March 29, 2015: On February 2016 the value of exports was 18 billion lekë, decreasing by 4.5 % compared with February 2015 and increasing by 7.2 % compared with January 2016. The value of imports in February 2016, was 42 billion lekë, increasing by 6.8 % compared with February 2015 and 19.1 % compared with January 2016. This month the trade deficit is 24 billion lekë signing an increase by 16.9 % compared with February 2015 and 29.6 % compared with January 2016.


Fig.1 Flow of goods, January 2014–February 2015 (billionALL)



The influence of the main groups in the annual change in exports:

In annual decrease of exports by 4.5 % this month a negative contribution was given by the groups: "Minerals, fuels, electricity" with -12.9 percentage point, "Construction materials and metals" with -2.7 percentage point, "Machinery, equipment spare parts" with -2.0 percentage point. While a positive contribution was given by the groups: "Textile and footwear" with +9.3 percentage point, "Food, beverages, tobacco" with +2.8 percentage point, "Leather and leather manufacture" with +0.4 percentage point.


Fig.2 Annual impact of groups in exports



The influence of the main groups in the annual change in imports:

In annual increase of imports by 1.5 % in February 2016 a positive contribution was given by the groups: "Textile and footwear" with +3.3 percentage point, "Chemical and plastical products" with +2.9 percentage point, "Machinery, equipment spare parts" with +2.4 percentage point. While a negative contribution was given by the groups., "Minerals, fuels, electricity" with -3.6 percentage point and "Wood manufactories and article of paper" with -0.2 percentage point


Fig.3 Annual impact of groups in imports



In February 2016, countries with which Albania has had the highest increase of exports, compared to February 2015 are: Italy with 6.0 %, Greece with 3.4 % and Germany with 32.6 %. While, countries with which has had a decrease of exports are: Kosovo with 34.9 %, Macedonia with 16.7 % and China with 65.9 %.

In February 2016, countries with which Albania has had the highest increase of imports, compared to February 2015 are: Italy with 11.7 %, China with 7.3 % and Greece with 11.2 %. While, countries with which has had a decrease of imports are: Serbia with 20.6 %, USA with 7.9 % and France with 3.0 %.

Trade with the EU countries is 71.0 % of total trade. In February 2016, exports to EU countries occuped 86.0 % of total export and imports from EU countries occuped 64.6 % of total import.

The main trade partners remain Italy (41.0 %), China (7.1 %), Greece (6.7 %) and Germany (6.5 %).

Exports are goods destined to a third country, placed under customs export or outward processing

arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs

frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under

customs procedure of release for free circulation, inward processing or processing under customs

control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing

country, or the price of a service delivered to a resident, before the payment of any import duties or other

taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics

and for customs tariffs.
