Foreign Trade in Goods

June, 2015

Tirana, July 28, 2016: On June 2016 the value of exports was 23 billion lekë, decreasing by 6.4 % compared with June 2015 and increasing by 10.1 % compared with May 2016. The value of imports in June 2016, was 51 billion lekë, increasing by 4.1 % compared with June 2015 and decreasing 1.6 % compared with May 2016. This month the trade deficit is 28 billion lekë signing an increase by 14.4 % compared with June 2015 and an decrease by 9.3 % compared with May 2016.




Fig.1 Flow of goods, May 2015 – June 2016 (billionALL)

The influence of the main groups in the annual change in exports:

In annual decrease of exports by 6.4 % this month a positive contribution was given by the groups: "Minerals, fuels, electricity" with -10.7 percentage point, "Construction materials and metals" with -2.9 percentage point and "Leather and leather manufactories" with -0.2 percentage point. While a positive contribution was given by the groups: "Textile and footwear" with +5.3 percentage point, "Food, beverages, tobacco" with +1.4 percentage point and "Machinery, equipment, spare parts" with +0.6 percentage point.




Fig.2 Annual impact of groups in exports

The influence of the main groups in the annual change in imports:

In annual increase of imports by 4.1 % in June 2016 a positive contribution was given by the groups: Machinery, equipment spare parts" with +7.5 percentage point, "Textile and footwear" with +2.4 percentage point, "Leather and leather manufactories" with +0.4 percentage point. While a negative contribution was given by the group: "Construction materials and metals" with -2.4 percentage point "Chemical and plastical products" with -1.7 percentage point, "Minerals, fuels, electricity" with -1.1 percentage point.





Fig.3 Annual impact of groups in imports

In June 2016, countries with which Albania has had the highest increase of exports, compared to June 2015 are: Italy with 28.5 %, Greece with 40.6 % and Serbia 7.3 %. While, countries with which has had a decrease of exports are: Kosovo with 36.2 %, Macedonia with 9.9 % and Spain me 80.3 %. In June 2016, countries with which Albania has had the highest increase of imports, compared to June 2015 are: Italy with 7.0 %, China with 51.0 % and Turkey with 15.2 %. While, countries with which has had a decrease of imports are: Greece with 13.1 %, Serbia with 27.6 % and France with 21.6 %.

Trade with the EU countries is 67.9 % of total trade. In June 2016, exports to EU countries occuped 78.4 % of total export and imports from EU countries occuped 63.2 % of total import. The main trade partners remain Italy (39.8 %), China (7.8 %), Greece (7.2 %) and Turkey (6.1 %).

DEFINITIONS

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to a resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
