


Foreign Trade in Goods

June 2017

Tirana, July 17, 2017: On June 2017 the value of exports was 23 billion lekë, decreasing by 0.3 % compared with the same period of previous year and by 7.1 % compared with May 2017. The value of imports in June 2017, was 56 billion lekë, increasing by 8.4 % compared with the same period of previous year and by 1.3 % compared with May 2017. This month the trade deficit is 34 billion lekë signing an increase by 15.1 % compared with June 2016 and by 7.9 % compared with May 2017.

Fig.1 Flow of goods, June 2015 – June 2017 (billion ALL)




In the first six months of 2017, the value of exports was 133 billion lekë, increasing by 13.5 %, compared with previous year and the value of imports was 295 billion lekë, increasing by 5.6 %. Trade deficit was 162 billion lekë, decreasing by 0.1 % compared with the same period of 2016.

The influence of the main groups in the annual change in exports:

In annual decrease of exports by -0.3 % this month a negative contribution was given by the groups: "Minerals, fuels, electricity" with -11.4 percentage point and "Wood manufacture and article of paper" with -0.02 percentage point. While a positive contribution was given by the groups: "Construction materials and metals" with +4.5 percentage point, "Textile and footwear" with +3.8 percentage point, "Machinery, equipment and spare parts" with +1.6 percentage point.

In the first six months of 2017, exports are increased by 13.5 % compared with previous year. A positive contribution was given by the groups: "Construction materials and metals" with +5.3 percentage point, "Textile and footwear" with +3.6 percentage point, "Minerals, fuels, electricity" with +1.9 percentage point, While a negative contribution was given by the group: "Wood manufacture and article of paper" with -0.1 percentage point.

The influence of the main groups in the annual change in imports:

In annual increase of imports by 8.4 % in June 2017 a positive contribution was given by the groups: "Construction materials and metals" with +3.7 percentage point, "Food, beverage, tobacco" with +2.4 percentage point, "Minerals, fuels, electricity" with +1.4 percentage point. While a negative contribution was given by the groups: "Machinery, equipment and spare parts" with -1.7 percentage point and "Wood manufacture and article of paper" with -0.1 percentage point.




Fig.3 Annual impact of groups in imports

In the first six months of 2017, imports are increased by 5.6 % compared with previous year. A positive contribution was given by the groups: "Chemical and plastical products" with +1.5 percentage point, "Textile and footwear" with +1.2 percentage point, "Food, beverage, tobacco" with +1.1 percentage point. While a negative contribution was given by the group: "Construction materials and metals" with -0.3 percentage point.

The performance of trade in goods by partner countries


In June 2017, countries with which Albania has had the highest increase of exports, compared to June 2016 are: Kosovo with (36.6 %), Spain with (218.4 %) and Germania with (49.1 %). While, countries with which has had a decrease of exports are: Italy with (-7.6 %), Greece with (-20.0 %) and Montenegro with (-14.3 %).

In the first six months of 2017, countries with which Albania has had the highest increase of exports, compared to the same period of 2016 are: Italy with (6.3 %), Kosovo with (26.8 %) and Spain with (167.7 %). While, countries with which has had a decrease of exports are: Switzerland with (-47.0 %), Netherland with (-6.6 %) and Croatia with (-35.0 %).

In June 2017, countries with which Albania has had the highest increase of imports, compared to June 2016 are: Italy with (3.8 %), Greece with (25.2 %) and Germany with (8.8 %). While, countries with which has had a decrease of imports are: China with (-21.9 %), United State with (-52.0 %) and Rusia with (-23.5 %).

In the first six months of 2017, countries with which Albania has had the highest increase of imports, compared to the same period of 2016 are: Italy with (3.8 %), Turkey with (13.0 %) and Greece with (10.8 %). While, countries with which has had a decrease of exports are: Germany with (-7.5 %), China with (-12.1 %) and United State with (-9.8 %).

Trade with the EU countries is 68.8 % of total trade. In June 2017, exports to EU countries occuped 78.3 % of total export and imports from EU countries occuped 65.0 % of total import. The main trade partners remain Italy (36.6 %), Greece (7.7 %), Germany (7.5 %) and Turkey (5.6 %).

Trade with the EU countries, in the first six months of 2017 is 66.3 % of total trade. In the first six months of 2017, exports to EU countries occuped 76.8 % of total export and imports from EU countries occuped 61.6 % of total import. The main trade partners are: Italy (37.3 %), Germany (7.2 %), Greece (7.0 %) and China (6.2 %).

DEFINITIONS

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
