

Enterprises with main activitiy trade, accommodation and food service activities dominate with 56 %. Trade activity continues to be the most favourite when decide for a new activity, and represents 37.4% of new enterprises. Producers of goods dominate in manufactured economic activity, with 52 %. Producers of services dominate in wholsale and retail trade; repair of motor vehicles and motorcyclesin, with 47%.

Fig. 1 Active enterprises by economic activity



Business Register

Manufactured represents the highest number of enterprises with 50 and more employed, with 21.1 % . About 90 % of enterprises are with 1-4 employed. Most of them, 69 %, have only one self-employer/ employee. Large enterprises with 50 and more employed represent in number 1.3 % of total active enterprises, but their contribution on employment is very sensitive, 50 %. About 52.6 % of active enterprises are concentrated in prefectures of Tirana and Fier. Domination of producers of services is an occurrence in all prefectures, varying from 80.0 % in prefecture of Fier up to 87.7 % in prefecture of Tirana. In 2014 enterprise birth rate is 15.4 % from 10,9 % in 2013. During 2014 are created 17,377 new enterprises. Prefecture of Lezha has the highest birth rate by 25.6 %, while prefecture of Dibër has the lowest level by 11.7 %.

Fig. 2 New enterprises by economic activity




Foreign and joint enterprises

5,245 enterprises have foreigner owner or part-owner. 5.6 % of the total foreign and joint enterprises are enterprises with 50 and more employed and hire 74.2 % of total employed. Big enterprises in this group carry out economic activity mainly in: produced clothes and shoes, call center and financial activity. 81.2 % of foreign and joint enterprises are concentrated in prefectures of Tirana and Durrës.

Female owner/administrator

28.5 % of total active enterprises are owned /managed by females. Trade economic activity is most favorite by females. Compared with males "Trade" economic activity has the highest participation of females, by 34.2 %. Also 47.9 % of enterprises owned/managed by females have trade economic activity. 16.1 % of active enterprises with 50 and more employed owned/managed by females. 47.5 % of enterprises owned/managed by females are in prefecture of Tirana, while the lowest level is in prefectures of Kukës and Dibër. In comparison to males the prefecture with the highest and lowest percentage of females as owner/ administrator of enterprises are respectively Tirana with 30.7 % and Kukësi with 15.6 %. 31 % of active enterprises created during 2014 have owner/administrator females.





Local units

From 112,537 active enterprises in 2014, 110,336 of them operate only in one location and are considered one local unit. 2,201 enterprises carry out their economic activity in more than one location. They cover 2 % of total active enterprises and hire 33.5 % of total number of employed. 78.6 % of local unit are concentrated in urban area and 51.3 % of them carry out their economic activity in prefectures of Tirana and Fier.




Fig. 4 Local Units by prefectures

Methodological Notes

Business Register holds all non-agricultural legal unit (enterprises and institutions) that performs their activity inside Albanian territory.

Legislative base
