## **Movements of citizens in Albania**

## **July 2017**

Tirana, 21 Agust 2017: The number of Albanian and foreign citizens arrivals to the territory of Albania, in July 2017 is 1,379,302, Compared with July 2016, this indicator increased by 2.8 %, The number of foreign citizens' arrivals in the country is 864,023 compared with July 2016, this number decreased by 0.1 %.

The number of citizen arrivals to the territory of Albania during the seven months of 2017, is 5,199,145, increasing by 5.6 %, compared with the same period of 2016.

In July 2017, among ten countries with the highest arrivals of citizens in Albania, those from Switzerland have the largest increase by 52.3%, while the highest decrease was achieved by Kosovo with 33.2%. In the seven months of 2017, the country with the highest arrivals of citizens in Albania, the largest from Poland with 71.1% and the largest decreased from Kosovo by 17.3% (see table 2).


Albanian and foreign citizens out of the country were 1,362,491 during July 2017 marking an increase by 6.3 %, compared with the same period of previous year, The number of Albanian citizens leaving the territory of Albania is 4961,163 in July 2017, Compared with July 2016, this number increased by 11.0 %.

The number of foreign citizens out of the territory of Albania during in the seven months of 2017 is 2,759,744 increasing by 4.9 %, compared with the same period of 2016.

In July arrivals of Albanian and foreign citizens by land comprised the largest share with 76.9 %, while air and sea arrivals comprised respectively 11.9 % and 11.2, % (see table 4).

**Departures**: Includes all exits at the border, Departures measure the flow of citizens who leave the country of reference, The main purpose of the visit is the goal without which travel would not be done, The purpose of the trip includes visits of visitors and tourists for::

Visits for personal purposes

- 2, Visit to frends and relatives
- 3, Same Day Visit
- 4, Health treatment
- 5, Religious
- 6, Others
- 7, Tranzit

Business category includes all business and professional activities outside the usual environment,
