


Foreign Trade in Goods

September 2017

Tirana, October 17, 2017: On September 2017 the value of exports was 24 billion lekë, increasing by 16.8 % compared with the same period of previous year and by 30.3 % compared with August 2017. The value of imports in September 2017, was 53 billion lekë, increasing by 10.5 % compared with the same period of previous year and by 7.6 % compared with August 2017. This month the trade deficit is 29 billion lekë signing an increase by 5.7 % compared with September 2016 and decreased by 5.9 % compared with August 2017.

Fig.1 Annual change in Foring Trade (%)




In the first nine months of 2017, the value of exports was 201 billion lekë, increasing by 13.3 %, compared with previous year and the value of imports was 453 billion lekë, increasing by 6.8 %. Trade deficit was 252 billion lekë, increasing by 2.1 % compared with the same period of 2016.

The influence of the main groups in the annual change in exports:

In annual increase of exports by 16.8 % this month a positive contribution was given by the groups: "Textile and footwear" with +5.9 percentage point, "Construction materials and metals" with +5.3 percentage point, "Food, beverage, tobacco" with +3.2 percentage point. While a negative contribution was given by the group: "Minerals, fuels, electricity" with -2.0 percentage point.






In the first nine months of 2017, exports are increased by 13.3 % compared with previous year. As nine months all groups affected positivity in annual increase of exports, who the groups that influenced more in annual increase of exports, are: "Construction materials and metals" with +5.2 percentage point, "Textile and footwear" with +4.1 percentage point, "Food, beverage, tobacco" with +1.9 percentage point. In the annual change in exports, no group affected negatively.

The influence of the main groups in the annual change in imports:

In annual increase of imports by 10.5 % in September 2017 a positive contribution was given by the groups: "Minerals, fuels, electricity" with +6.3 percentage point, "Machinery, equipment, spare parts" with +3.3 percentage point, "Textile and footwear" with +1.7 percentage point. While a negative contribution was given by the group: "Construction materials and metals" with -3.9 percentage point.





As nine months, imports are increased by 6.8 % compared with nine months 2016. A positive contribution was given by the groups: "Minerals, fuels, electricity" with +2.0 percentage point, "Textile and footwear" with +1.3 percentage point, "Chemical and plastical products" with +1.2 percentage point. While a negative contribution was given by the group: "Construction materials and metals" with -0.1 percentage point.

The performance of trade in goods by partner countries

In September 2017, countries with which Albania has had the highest increase of exports, compared to September 2016 are: Italy with (12.0 %), Kosovo with (31.2 %) and Spain with (207.2 %). While, countries with which has had a decrease of exports are: Montenegro with (-14.5 %), Switzerland with (-37.0 %) and Netherlands with (-51.4 %).

In the first nine months of 2017, countries with which Albania has had the highest increase of exports, compared to the same period of 2016 are: Italy with (8.8 %), Kosovo with (29.0 %) and Spain with (126.4 %). While, countries with which has had a decrease of exports are: Switzerland with (-49.2 %), Netherlands with (-4.4 %) and Croatia with (-20.9 %).

In September 2017, countries with which Albania has had the highest increase of imports, compared to September 2016 are: Italy with (13.6 %), Greece with (8.9 %) and China with (1.2 %). While, countries with which has had a decrease of imports are: Germany with (-30.1 %), Turkey with (-0.7 %) and Spain with (-14.9 %).

In the first nine months of 2017, countries with which Albania has had the highest increase of imports, compared to the same period of 2016 are: Italy with (5.0 %), Greece with (12.8 %) and Turkey with (11.5 %). While, countries with which has had a decrease of exports are: Germany with (-8.3 %), China with (-5.6 %) and France with (-10.1 %).




Fig.4 ForeignTrade in Goods by several EU countries, September 2017

Trade with the EU countries is 64.9 % of total trade. In September 2017, exports to EU countries occuped 77.8 % of total export and imports from EU countries occuped 59.0 % of total import. The main trade partners remain Italy (35.9 %), Germany (7.0 %), Greece (6.7 %) and China (6.5 %).

Trade with the EU countries, in the first nine months of 2017 is 65.9 % of total trade. In the first nine months of 2017, exports to EU countries occuped 76.7 % of total export and imports from EU countries occuped 61.0 % of total import. The main trade partners are: Italy (36.3 %), Greece (7.1 %), Germany (7.1 %) and China (6.4 %).
