## **Transport statistics**

### August 2017

**Tirana, 27 Septmber 2017:** The volume of freight loading/unloading in ports, in August is 300 thousand tonnes. Compared with August 2016, this indicator decresed by 9.3 %.

In the eighth month of 2017, the volume of freight loading/unloading in ports is 2,619 thousand tonnes, increasing by 6.9 % compared to the same period of year 2016.

Durrës port occupies 88.0 %, all loaded/unloaded freights in all ports.

The volume of freights transported by rail is 2.1 million tonnes-km, increasing 95.7 % compared to August 2016.

In the eght months of 2017, volume of freights transported by rail is 16 million tonnes-km, increasing nearly 2.5 times compared with the same period of 2016.

In August 2017, the number of passengers traveling with airline is 328,317, increasing by 26.8 % compared to August 2016.

In the eight months of 2017, passenger air transport occupies 59.7 % of the total transport of passenger by rail, by sea and by air. The number of passengers traveling by air in the eight months of 2017 is 1,741,707 persons, increasing by 24.6 % compared to the same period of year 2016.

#### Exports/Imports of goods by mode of transport


In August 2017, the value of goods traded (exports and imports) is 68 billion lekë and 47.8 % of them is transported by sea.

#### **Exports of goods**

In August 2017, goods eksported by sea represent 56.0 %, by road 42.7 % and by air 0.8% of total exports of goods.

Goods exported by road, in August 2017, increased by 30.6 % and by sea 2.1 %, compared with August 2016.

In the eight months of 2017, goods exported by sea represent 62.9 %, by road 35.7 % and by air 0.5 of total exports of goods.


Goods exported by road, in the eight months of 2017, increased by 26.5 % and by sea increased by 8.7 %, compared with the same period of 2016.

#### Imports of goods

In August 2017, goods imported by sea represent 44.8 %, by road 45.4 % and by air 2.5 %.

Goods imported by sea, in August 2017, decreased by 3.8 % and by air decreased by 50.1 %, compared with August 2016.

Fig. 2 Structure of imports by mode of transport, August 2017




In the eight months of 2017, goods imported by sea represent 49.6%, by road 44.2% and by air 2.8%.

Goods imported by rail, in eight months of 2017, increased by 63.6 % and by air decreased by 13.1 %, compared with the same period of 2016.

#### Main goods exported, by mode of transport

Five main group of goods exported, by Standard Goods Classification for Transport Statistics (NST 2007), represent 76.5 %, of the total value of goods exported in August 2017.

Fig. 3 Five main group of goods exported, by mode of transport



# Methodology

#### **Definitions**

Airlines include companies that transporting passengers and goods.

**Transport**: Movement of people and / or freights using various means of transport. Transport July be carried out by land, air and sea means.

Rail transport: Every movement of freigts and / passengers using wheeled vehicles run on the track.

**Maritime transport**: Any movement of goods and / or passengers using commercial vessel trips, which are undertaken wholly or partly by sea.

**Air transport**: Any movement of freights and / or passengers using aircraft on trips, which are undertaken wholly or partly by air.

**Exports** are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

**Imports** are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

**Standard Goods Classification for Transport Statistics (NST2007)** is a goods nomenclature used mainly for transports statistics

**Sorce data:** The data are provided by the Ministry of Transport and Infrastructure aand General Directorate of Customs
