


Foreign Trade in Goods

November 2017

Tirana, December 18, 2017: On November 2017 the value of exports was 25 billion lekë, increasing by 11.0 % compared with the same period of previous year and by 2.3 % compared with October 2017. The value of imports in November 2017, was 54 billion lekë, increasing by 10.1 % compared with the same period of previous year and decreased by 5.3 % compared with October 2017. This month the trade deficit is 29 billion lekë signing an increase by 9.3 % compared with November 2016 and decreased by 11.1 % compared with October 2017.

Fig.1 Annual change in Foring Trade (%)




In the first eleven months of 2017, the value of exports was 251 billion lekë, increasing by 13.2 %, compared with previous year and the value of imports was 565 billion lekë, increasing by 8.0 %. Trade deficit was 314 billion lekë, increasing by 4.1 % compared with the same period of 2016.

The influence of the main groups in the annual change in exports:

In annual increase of exports by 11.0 % this month a positive contribution was given by the groups: "Construction materials and metals" with +5.7 percentage point, "Textile and footwear" with +5.2 percentage point and "Food, beverage, tobacco" with +3.1 percentage point. While a negative contribution was given by the groups: "Minerals, fuels, electricity" with -6.1 percentage point and "Leather and leather manufactories" with -0.1 percentage point.

Fig.2 Contribution of groups in annual change of exports, November 2017




In the eleven months of 2017, exports are increased by 13.2 % compared with previous year. As ten months the groups affected positivity in annual increase of exports, are: "Construction materials and metals" with +5.2 percentage point, "Textile and footwear" with +4.4 percentage point, "Food, beverage, tobacco" with +1.9 percentage point. In the annual change in exports a negative contribution was given by the group: "Minerals, fuels, electricity" with -0.5 percentage point

The influence of the main groups in the annual change in imports:

In annual increase of imports by 10.1 % in November 2017 a positive contribution was given by the groups: "Minerals, fuels, electricity" with +2.2 percentage point, "Textile and footwear" with +2.1 percentage point, "Chemical and plastical products" with +2.1 percentage point. While a negative contribution was given by the group: "Machinery, equipment, spare parts" with -1.2 percentage point.





As eleven months, imports are increased by 8.0 % compared with ten months 2016. As eleven months all groups affected positivity in annual increase of imports, who the groups that influenced more in annual increase of imports, are: "Minerals, fuels, electricity" with +2.3 percentage point, "Textile and footwear" with +1.3 percentage point, "Chemical and plastical products" with +1.3 percentage point.

The performance of trade in goods by partner countries


In November 2017, countries with which Albania has had the highest increase of exports, compared to November 2016 are: Italy with (14.5 %), Kosovo with (37.5 %) and Spain with (26.8 %). While, countries with which has had a decrease of exports are: China with (-40.0 %), Macedonia with (-1.5 %) and Serbia with (-1.1 %).

In the eleven months of 2017, countries with which Albania has had the highest increase of exports, compared to the same period of 2016 are: Italy with (9.3 %), Kosovo with (30.7 %) and Spain with (107.2 %). While, countries with which has had a decrease of exports are: Turkey with (-30.7 %), Netherlands with (-10.1 %) and Switzerland with (-55.6 %).

In November 2017, countries with which Albania has had the highest increase of imports, compared to November 2016 are: Italy with (11.3 %), China with (17.3 %) and Turkey with (15.8 %). While, countries with which has had a decrease of imports are: Greece with (-8.2 %), Spain with (-17.1 %) and USA with (-33.1 %).

In the eleven months of 2017, countries with which Albania has had the highest increase of imports, compared to the same period of 2016 are: Italy with (6.1 %), Turkey with (11.8 %) and Greece with (9.2 %). While, countries with which has had a decrease of exports are: Germany with (-5.4 %), China with (-2.8 %) and France with (-5.4 %).





Trade with the EU countries is 66.0 % of total trade. In November 2017, exports to EU countries occuped 78.3 % of total export and imports from EU countries occuped 60.3 % of total import. The main trade partners remain Italy (37.1 %), China (7.1 %) Germany (6.5 %) and Turkey (6.2 %).

Trade with the EU countries, in the eleven months of 2017 is 66.3 % of total trade. In the eleven months of 2017, exports to EU countries occuped 77.0 % of total export and imports from EU countries occuped 61.6 % of total import. The main trade partners are: Italy (36.3 %), Greece (6.9 %), Germany (6.9 %) and China (6.4 %).
