Foreign Trade in Goods

December 2017


Tirana, January 17, 2018: In 2017, the value of exports was 273 billion lekë, increasing by 12.1 %, compared with previous year and the value of imports was 626 billion lekë, increasing by 8.1 %. Trade deficit was 353 billion lekë, increasing by 5.2 % compared with the same period of 2016.

Exports in 2017, are increased by 12.1 % compared with previous year. The groups affected positivity in annual increase of exports, are: "Construction materials and metals" with +4.9 percentage point, "Textile and footwear" with +4.4 percentage point, "Food, beverage, tobacco" with +1.9 percentage point. In the annual change in exports a negative contribution was given by the group: "Minerals, fuels, electricity" with -1.4 percentage point.

In 2017, imports are increased by 8.1 % compared with previous year. During 2017 all groups affected positivity in annual increase of imports, who the groups that influenced more in annual increase of imports, are: "Minerals, fuels, electricity" with +2.8 percentage point, "Textile and footwear" with +1.2 percentage point, "Chemical and plastical products" with +1.2 percentage point.

Trade with the EU countries, in 2017 is 66.3 % of total trade. During 2017, exports to EU countries occuped 77.1 % of total export and imports from EU countries occuped 61.6 % of total import. The main trade partners are: Italy (36.2 %), Greece (6.8 %), Germany (6.8 %) and China (6.4 %).

Fig.1 Annual change in Foring Trade (%)





On December 2017 the value of exports was 22 billion lekë, increasing by 0.6 % compared with the same period of previous year and decreasing by 13.5 % compared with November 2017. The value of imports in December 2017, was 61 billion lekë, increasing by 8.9 % compared with the same period of previous year and by 11.1 % compared with November 2017. This month the trade deficit is 39 billion lekë signing an increase by 14.2 % compared with December 2016 and by 32.5 % compared with November 2017.

The influence of the main groups in the annual change in exports:

In annual increase of exports by 0.6 % this month a positive contribution was given by the groups: "Textile and footwear" with +4.6 percentage point, "Food, beverage, tobacco" with +1.9 percentage point and "Construction materials and metals" with +1.8 percentage point. While a negative contribution was given by the group: "Minerals, fuels, electricity" with -10.5 percentage point.


Fig.2 Contribution of groups in annual change of exports, December 2017



The influence of the main groups in the annual change in imports:

In annual increase of imports by 8.9 % in December 2017 a positive contribution was given by the groups: "Minerals, fuels, electricity" with +7.6 percentage point, "Food, beverage, tobacco" with +0.9 percentage point, "Chemical and plastical products" with +0.4 percentage point. While a negative contribution was given by the group: "Construction materials and metals" with -3.2 percentage point.





The performance of trade in goods by partner countries


In December 2017, countries with which Albania has had the highest increase of exports, compared to December 2016 are: Italy with (17.0 %), Germany with (16.8 %) and Macedonia with (19.3 %). While, countries with which has had a decrease of exports are: Kosovo with (-14.7 %), Spain with (-3.6 %) and Greece with (-17.0 %).

In 2017, countries with which Albania has had the highest increase of exports, compared to 2016 are: Italy with (9.9 %), Kosovo with (26.0 %) and Spain with (87.5 %). While, countries with which has had a decrease of exports are: Turkey with (-24.0 %), Switzerland with (-48.0 %) and Netherlands with (-4.0 %).

In December 2017, countries with which Albania has had the highest increase of imports, compared to December 2016 are: Italy with (1.4 %), Greece with (9.5 %) and Turkey with (4.7 %). While, countries with which has had a decrease of imports are: China with (-1.2 %), Germany with (-27.3 %) and USA with (-7.8 %).

In 2017, countries with which Albania has had the highest increase of imports, compared to 2016 are: Italy with (5.7 %), Turkey with (11.2 %) and Greece with (9.2 %). While, countries with which has had a decrease of exports are: Germany with (-7.7 %), China with (-2.6 %) and France with (-4.4 %).

Trade with the EU countries is 66.3 % of total trade. In December 2017, exports to EU countries occuped 78.3 % of total export and imports from EU countries occuped 62.0 % of total import. The main trade partners remain Italy (34.6 %), China (6.8 %) Greece (6.5 %) and Germany (6.3 %).
