Foreign Trade in Goods

January 2018

Tirana, February 19, 2018: On January 2018 the value of exports was 23 billion lekë, increasing by 23.6 % compared with the same period of previous year and by 6.4 % compared with December 2017. The value of imports in January 2018, was 45 billion lekë, increasing by 27.0 % compared with the same period of previous year and decreased by 26.5 % compared with December 2017. This month the trade deficit is 21.3 billion lekë signing an increase by 31.1 % compared with January 2017 and decreased by 45.1 % compared with December 2017.





Fig.1 Annual change in Foring Trade (%)

The influence of the main groups in the annual change in exports:

In annual increase of exports by 23.6 % this month a positive contribution was given by the groups: "Construction materials and metals" with +10.5 percentage point, "Textile and footwear" with +8.1 percentage point, "Food, beverage, tobacco" with +2.7 percentage point. While a negative contribution was given by the group: "Minerals, fuels, electricity" with -1.9 percentage point.

Fig.2 Contribution of groups in annual change of exports, January 2018




The influence of the main groups in the annual change in imports:

In annual increase of imports by 27.0 % in January 2018 a positive contribution was given by the groups: "Minerals, fuels, electricity" with +10.9 percentage point, "Machinery, equipment, spare parts" with +5.6 percentage point, "Construction materials and metals" with +3.3 percentage point. No group has affected negatively in annual change of imports.

The performance of trade in goods by partner countries

In January 2018, countries with which Albania has had the highest increase of exports, compared to January 2017 are: Italy with (6.1 %), Spain with (114.6 %) and Kosovo with (43.7 %). While, countries with which has had a decrease of exports are: France with (-15.4 %), Romania with (-6.8 %) and Hungary with (-18.7 %).

In January 2018, countries with which Albania has had the highest increase of imports, compared to January 2017 are: Italy with (14.9 %), Turkey with (40.2 %) and China with (12.9 %). While, countries with which has had a decrease of imports are: USA with (-11.9 %), Russia with (-30.8 %) and Egypt with (-7.5 %).




Fig.4 ForeignTrade in Goods by several EU countries, January 2018

In January 2018, trade with the EU countries is 67.1 % of total trade. Exports to EU countries occuped 81.5 % of total export and imports from EU countries occuped 59.5 % of total import. The main trade partners remain Italy (35.6 %), Greece (7.2 %), China (6.7 %) and Germany (6.2 %).

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing,

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier,

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control,

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country,

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs,

Member State of European Union Belgium, Germany, France, Italy, Luxembourg, Netherlands, United Kingdom, Denmark, Ireland, Greece, Spain, Portugal, Austria, Finland, Sweden, Cyprus, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Slovakia, Slovenia, Bulgaria, Romania, Croatia.
