


Foreign Trade in Goods

April 2018

Tirana, May 17, 2018: On April 2018 the value of exports was 27 billion lekë, increasing by 11.2 % compared with the same period of previous year and decreasing by 1.4 % compared with March 2018. The value of imports was 52 billion lekë, increasing by 4.9 % compared with the same period of previous year and decreasing by 5.2 % compared with March 2018. This month the trade deficit is 26 billion lekë signing an decrease by 0.9 % compared with April 2017 and by 8.9 % compared with March 2018.

Fig.1 Annual change in Foring Trade (%)




In the first fourth months of 2018, the value of exports was 101 billion lekë, increasing by 16.8 %, compared with previous year and the value of imports was 198 billion lekë, increasing by 8.4 %. Trade deficit was 97 billion lekë, increasing by 0.8 % compared with the same period of 2017.

The influence of the main groups in the annual change in exports:

In annual increase of exports by 11.2 % this month a positive contribution was given by the groups: "Minerals, fuels, electricity" with +5.3 percentage point, "Textile and footwear" with +2.0 percentage point, "Construction materials and metals" with +1.7 percentage point ". While a negative contribution was given by the groups: "Machinery, equipment, spare parts" with -0.4 percentage point, "Leather and leather manufactories" with -0.1 percentage point.

Fig. 2 Contribution of groups in annual change of exports, April 2018




Exports in the first fourth months of 2018 are increased by 16.8 % compared with the same period of previous year. All groups affected positivity in annual increase of exports, who the groups that influenced more in annual increase of imports, are: "Construction materials and metals" with +4.5 percentage point, "Textile and footwear" with +4.4 percentage point, "Minerals, fuels, electricity" with +3.4 percentage point.

The influence of the main groups in the annual change in imports:

In annual increase of imports by 4.9 % in April 2018 a positive contribution was given by the groups: "Minerals, fuels, electricity" with +2.3 percentage point, "Machinery, equipment, spare parts" with +2.2 percentage point, "Chemical and plastical products" with +1.9 percentage point. While a negative contribution was given by the group: "Construction materials and metals" with -2.1 percentage point.

In the first fourth months of 2018, imports are increased by 8.4 % compared with the same period of previous year. During the first fourth months of 2018 the groups affected positivity in annual increase of imports, are: "Machinery, equipment, spare parts" with +3.1 percentage point, "Minerals, fuels, electricity" with +2.4 percentage point, "Textile and footwear" with +0.9 percentage point. While a negative contribution was given by the group: "Chemical and plastical products" with -0.01 percentage point.

The performance of trade in goods by partner countries


In April 2018, countries with which Albania has had the highest increase of exports, compared to April 2017 are: Italy with (9.7 %), Spain with (6.6 %) and Serbia with (133.8 %). While, countries with which has had a decrease of exports are: Kosovo with (-10.6 %), Greece with (-1.7 %) and China with (-69.6 %).

In the first fourth months of 2018, countries with which Albania has had the highest increase of exports, compared to the same period of 2017 are: Italy with (6.5 %), Spain with (90.6 %) and Germany with (30.4 %). While, countries with which has had a decrease of exports are: Kosovo with (-4.3 %), China with (-27.0 %) and Macedonia with (-2.8 %).

In April 2018, countries with which Albania has had the highest increase of imports, compared to April 2017 are: Turkey with (10.5 %), China with (5.9 %) and Romania with (142.5 %). While, countries with which has had a decrease of imports are: Italy with (-1.7 %), Greece with (-4.8 %) and Germany with (-4.5 %).

In the first fourth months of 2018, countries with which Albania has had the highest increase of imports, compared to the same period of 2017 are: Italy with (4.3 %), Germany with (6.2 %) and Turkey with (8.7 %). While, countries with which has had a decrease of exports are: Serbia with (-18.7 %), Spain with (-4.1 %) and Egypt with (-18.8 %).

Trade with the EU countries is 65.7 % of total trade. In April 2018, exports to EU countries occuped 72.9 % of total export and imports from EU countries occuped 62.1 % of total import. The main trade partners remain Italy (35.1 %), Greece (6.5 %), Germany (6.4 %) and Turkey (5.9 %).

Trade with the EU countries, in the first fourth months of 2018 is 67.7 % of total trade. In the first fourth months of 2018, exports to EU countries occuped 78.3 % of total export and imports from EU countries occuped 62.3 % of total import. The main trade partners are: Italy (35.6 %), Germany (7.3 %), Greece (6.8 %) and China (5.8 %).

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing,

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier,

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control,

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country,

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs,
