Development Strategy of INSTAT 2017-2030

The main strategic objectives of INSTAT for 2017- 2030 are:

Objective 1: Timely and quality output and distribution of statistical data in the economic, social, demographic and environmental fields at the central and local level.

Objective 2: Use of appropriate data sources and instruments to improve the production and quality of indicators and statistical services.

Objective 3: Professional and organizational improvement of the National Statistical System.

Objective 4: Development of innovative ITC systems for statistical processing, data exchange and communication.













National Statistical System

Law No.17/2018 on Official Statistics

The National Statistical System shall consist of the following official statistics producers:

- Institute of Statistics and its subordinate regional statistical offices;
- Bank of Albania;
- Other public authorities determined under the official statistics production program.













INSTAT coordinating activities

- Cooperating with official statistics producers in designing and implementing the program;
- Ensuring the uniformity of methodology used during statistical surveys;
- Providing technical support to ensure the statistical activities compliance with international standards;
- Participating in the establishment and development processes of administrative data systems, to be used for statistical purposes;
- Representing the National Statistical System(NSS) in the European Statistical System and international organizations and to maintain relations with other countries' national statistics institute













INSTAT coordinating work

- Request the statistical agencies to submit reports every 4 month;
- Monitor the procedures for the production and dissemination of official statistics;
- Give opinion on any statistical survey prior to its start;
- Submit to the Albanian Parliament within April of the following year, the annual report, which should include the functioning of the NSS;
- Organize and chair large scale advisory meetings;
- Publish on the website, a detailed calendar of dates on which official statistics produced by the NSS;
- Memoranda of understanding with all statistical agencies and holders of administrative;
- Direct and administer the Statistical Training Center.











INSTAT Strategy Objective 2

Objective 2: Use of appropriate data sources and instruments to improve the production and quality of indicators and statistical services.

- 2.2 Use of IT systems and tools for Data Collection.

INSTAT Strategy Objective 2.1

2.1 Increase the use of administrative data, administrative records for statistical purposes.

Continuous coordination with administrative data providers respecting the principles of statistical confidentiality.

The advantages and disadvantages of using administrative data sources:

- Coherence;
- Timeliness:
- Coverage;
- Quality of the statistical products;
- Costs;
- Response burden.

- Differences in concepts, definitions and methodologies;
- Accuracy of specific variables;
- Differences in formats and identifiers;
- Timeliness.

 - Private companies














Processes and Preconditions















- In 2017 has signed 19 MoUs in cooperation with the line ministries and other public institutions.

Administrative data sources

- Uses of administrative data:
 - Use at micro level;
 - Use as auxiliary information at micro level;
 - Use as auxiliary information at aggregate level;
 - Use as source for updating statistical registers;
 - Use as circumstantial evidence.
- 24 different data providers:
 - 10 Micro datasets;
 - 90 Aggregated datasets.










Administrative data frequency
















Administrative data in official statistics
