


Foreign Trade in Goods

September 2018

Tirana, October 17, 2018: On September 2018 the value of exports was 26 billion lekë, increasing by 8.7 % compared with the same period of previous year and by 28.0 % compared with August 2018. The value of imports was 51 billion lekë, decreasing by 4.7 % compared with the same period of previous year and increasing by 5.5 % compared with August 2018. This month the trade deficit is 25 billion lekë signing a decrease by 15.6 % compared with September 2017 and 11.1 % compared with August 2018.

Fig. 1 Annual change in Foring Trade (%)




In nine months of 2018, the value of exports was 231 billion lekë, increasing by 15.3 %, compared with previous year and the value of imports was 467 billion lekë, increasing by 3.0 %. Trade deficit was 235 billion lekë, decreasing by 6.7 % compared with the same period of 2017.

The influence of the main groups in the annual change in exports:

In annual increase of exports by 8.7 % this month a positive contribution was given by the groups: "Construction materials and metals" with +3.2 percentage point, "Minerals, fuels, electricity" with +2.3 percentage point, "Chemical and plastical products" with +1.9 percentage point. While a negative contribution was given by the group: "Machinery, equipment, spare parts" with -0.8 percentage point.

Fig. 2 Contribution of groups in annual change of exports, September 2018




Exports in nine months of 2018 are increased by 15.3 % compared with the same period of previous year. The groups that influenced more in annual increase of imports are: "Minerals, fuels, electricity" with +5.6 percentage point, "Construction materials and metals" with +4.1 percentage point, "Textile and footwear" with +2.7 percentage point. While a negative contribution give the group: "Leather and leather manufacture" with -0.04 point percent.

The influence of the main groups in the annual change in imports:

In annual decrease of imports by 4.7 %, this month has mainly affected the groups: "Minerals, fuels, electricity" with -4.1 percentage point, "Machinery, equipment, spare parts" with -1.0 percentage point, "Wood manufactures and articles of paper" with -0.6 percentage point. While a positive contribution was given by the group: "Construction materials and metals" with +0.7 percentage point.





In nine months of 2018, imports are increased by 3.0 % compared with the same period of previous year. The groups affected positivity in annual increase of imports, are: "Machinery, equipment, spare parts" with +1.3 percentage point, "Minerals, fuels, electricity" with +0.6 percentage point, "Textile and footwear" with +0.3 percentage point. While no group give a negative contribution.

The performance of trade in goods by partner countries

In September 2018, countries with which Albania has had the highest increase of exports, compared to August 2017 are: Italy with (-0,9 %), Kosovo with (50.0 %) and Spain (47.4 %). While, countries with which has had a decrease of exports are: China with (-77.8 %), Turkey with (-1.9 %) and Ukraine with (-54.0 %).


In nine months of 2018, countries with which Albania has had the highest increase of exports, compared to the same period of 2017 are: Italy with (3.9 %), Kosovo with (25.0 %) and Spain with (63.1 %). While, countries with which has had a decrease of exports are: China with (-38.3 %), Turkey with (-5.6 %) and Ukraine with (-53.1 %).

In September 2018, countries with which Albania has had the highest increase of imports, compared to August 2017 are: Greece with (13.8 %), Turkey with (15.4 %), and China with (8.2 %). While, countries with which has had a decrease of imports are: Italy with (-7.3 %), Germany with (-23.3 %) and Russia with (-2.2 %).

In nine months of 2018, countries with which Albania has had the highest increase of imports, compared to the same period of 2017 are: Greece with (2.8 %), Turkey with (5.1 %) and China with (8.6 %). While, countries with which has had a decrease of exports are: Germany with (-4.5 %), Switzerland with (-23.6 %) and Ukraine with (-17.1 %).

Trade with the EU countries is 66.4 % of total trade. In September 2018, exports to EU countries occuped 76.6 % of total export and imports from EU countries occuped 61.1 % of total import. The main trade partners remain Italy (34.8 %), Greece (7.6 %), Turkey (6.2 %) and China (5.9 %).

Trade with the EU countries, in eight months of 2018 is 66.5 % of total trade. In the first nine months of 2018, exports to EU countries occuped 76.4 % of total export and imports from EU countries occuped 61.7 % of total import. The main trade partners are: Italy (34.6 %), Greece (7.0 %), Germany (6.7 %) and China (6.0 %).

Exports are goods destined to a third country, placed under customs export or outward processing

arrangements or re-exported following inward processing,

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs

frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under

customs procedure of release for free circulation, inward processing or processing under customs

control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing

country, or the price of a service delivered to resident, before the payment of any import duties or other

taxes on imports or trade and transport margins within the country,

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics

and for customs tariffs,
