

Movements of citizens in Albania

September 2018

Tirana, 23 Otober 2018: The number of Albanian and foreign citizens arrivals to the territory of Albania, in September 2018 is 1,121,116, compared with September 2017, this indicator increased 31.5 %.


In September 2018, the number of foreign citizens' arrivals in the country is 664,184. Compared with September 2017, this number increased 44.6 %.

The number of foreign citizen arrivals to the territory of Albania during in nine months of 2018, is 5,061,822 increasing by 19.8 %, compared with the same period of 2017.

In September 2018, among the countries with the highest incomes of citizens in Albania, Kosovo had the highest growth by 66.0 %, with only 16.3% of the citizens from Montenegro.

In nine months of 2018, the country with the highest arrivals of citizens in Albania, the largest increase in inflows came from Poland 37.2 %

Albanian and foreign citizens' departures the country during September 2018 is janë 1,336.203 marking an increase of me 26.9 % compared to the same period of the previous year. The number of Albanian citizens leaving the territory of Albania during September 2018 is 515,676 compared to September 2017; this number has increased by 3.4 %. The number of foreign citizens leaving the territory of Albania during September 2018 is 820,527, compared to September 2017, this number increased by 48.0 %.

The number of Albanian citizens leaving the territory of our country in nine months 2018 is 4,066,178 increasing by rritur 3.3 %, compared to the same period of the previous year.

Definitions

Visitor: For statistical purposes on tourism, the term "visitor" represents a "person who travels in a different place from that in which he resides, in a period shorter than 12 months and major aim of travel in the place visited is a non-profit activity",

Arrivals: Include all entries at the border,

Arrivals is a concept that refers to all entries, A person who visits some countries simultaneously during the year is calculated every time a new entr,y

Departures: Includes all exits at the border, Departures measure the flow of citizens who leave the country of reference, The main purpose of the visit is the goal without which travel would not be done, The purpose of the trip includes visits of visitors and tourists for::

Visits for personal purposes

- 1, Holidays
- 2, Visit to frends and relatives
- 3, Same Day Visit
- 4, Health treatment
- 5, Religious
- 6, Others
- 7, Tranzit

Business category includes all business and professional activities outside the usual environment,
