


Foreign Trade in Goods

December 2018

Tirana, January 17, 2019: On December 2018 the value of exports was 22 billion lekë, decreasing by 1.7 % compared with the same period of previous year and by 20.5 % compared with November 2018. The value of imports was 60 billion lekë, decreasing by 1.3 % compared with the same period of previous year and increased by 6.9 % compared with November 2018. This month the trade deficit is 38 billion lekë, signing a decrease by 1.0 % compared with December 2017 and increasing by 32,6 % compared with November 2018.

In year of 2018, the value of exports was 310 billion lekë, increasing by 13,7 %, compared with previous year and the value of imports was 641 billion lekë, increasing by 2,4 %. Trade deficit was 331 billion lekë, decreasing by 6,3 % compared with the same period of 2017.

The influence of the main groups in the annual change in exports:

In annual decrease of exports by 1.7 % this month, a positive contribution was given by the groups: "Textile and footware" with -2.1 percentage point, "Wood manufactures and articles of paper" with -0.5 percentage point, "Construction materials and metals" with -0.4 percentage point. While, a positive contribution was given by the group: "Minerals, fuels, electricity" with +0.9 percentage point.




Fig.2 Contribution of groups in annual change of exports, December 2018

Exports in year of 2018 are increased by 13.7 % compared with the same period of previous year. The groups that influenced more in annual increase of imports are: "Minerals, fuels, electricity" with +4.9 percentage point, "Construction materials and metals" with +3.4 percentage point, "Textile and footwear" with +2.3 percentage point. While a negative contribution give the group: "Leather and leather manufacture" with -0.1 point percent.

The influence of the main groups in the annual change in imports:

In annual decrease of imports by 1.3 %, this month has mainly affected the groups: "Minerals, fuels, electricity" with -1.3 percentage point, "Machinery, equipment, spare parts" with -1.2 percentage point. While, a positive contribution was given by the group: "Construction materials and metals" with +2.4 percentage point.




Fig.3 Contribution of groups in annual change of imports, December 2018

In year of 2018, imports are increased by 2.4 % compared with the same period of previous year. The groups affected positivity in annual increase of imports, are: "Machinery, equipment, spare parts" with +1.3 percentage point, "Minerals, fuels, electricity" with +0.4 percentage point, "Construction materials and metals" with +0.3 percentage point. While a negative contribution was given by the group "Food, beverage and tobacco" with -0.04 percentage point.

The performance of trade in goods by partner countries

In December 2018, countries with which Albania has had the highest increase of exports, compared to December 2017 are: Kosovo (44.5 %), Spain (9.9 %) and Germany (7.1 %). While, countries with which has had a decrease of exports are: Italy (-11.3 %), Greece (-2.8 %) and Macedonia (-9.6 %).

In year of 2018, countries with which Albania has had the highest increase of exports, compared to the same period of 2017 are: Italy (2.1 %), Kosovo (29.5 %) and Spain (61.2 %). While, countries with which has had a decrease of exports are: China (-32.2 %), and Ukraine (-45.9 %).

In December 2018, countries with which Albania has had the highest increase of imports, compared to December 2017 are: Turkey (31.8 %), China (6.1 %) and Greece (12.8 %). While countries with which has had a decrease of imports are: Italy (-12.9 %), USA (-12.9 %) and Sapin (-26.3 %).

In year of 2018, countries with which Albania has had the highest increase of imports, compared to the same period of 2017 are: Turkey (6.7 %), China (8.7 %) and Greece (4.5 %). While, countries with which has had a decrease of exports are: Italy (-2.2 %), Germany (-2.3 %), and Switzerland (-23.3 %).




Fig.4 ForeignTrade in Goods by several EU countries, December 2018

Trade with the EU countries is 61.2 % of total trade. In December 2018, exports to EU countries occuped 75.6 % of total export and imports from EU countries occuped 56.1 % of total import. The main trade partners remain Italy (30.7 %), China and Greece (7.3 %), Turkey (7.1 %).

Trade with the EU countries, in year of 2018 is 65.9 % of total trade. In the first year of 2018, exports to EU countries occuped 76.3 % of total export and imports from EU countries occuped 60.8 % of total import. The main trade partners are: Italy (34.1 %), Greece (6.9 %), Germany (6.6 %) and China (6.3 %).

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier,

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control,

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country,

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs,
