


# **Producer price Index**

# First quarter, 2019

**Tirana, 07 June 2019:** In first quarter 2019, Producer Price Index reached 103.1, decreasing by 0.2 %, compared with first quarter 2018.

Producer Price Index, in first quarter 2019, decreased by 0.2 % compared with fourth quarter 2018.



**Annual change: Producer Price Index** in "Manufacturing" section decreased by 0.7 % compared with first quarter 2018. Within this section prices decreased the most in "Manufacture of food products" activity by 1.9 %, followed by "Manufacture of non-metallic mineral products" by 0.5 % and "Metallurgy" by 0.2 %. Producer Price Index in "Mining and quarrying" section decreased by 0.1 % compared with first quarter 2018. Within this section prices decreased the most in "Extraction of crude petroleum and natural gas, auxiliary services" activity by 1.3 %.

**Producer Price Index for Domestic Market:** Compared with the same period of 2018 the index signed an increase by 0.2 %. The index in the "Mining and quarrying" section marked an increase by 1.7%.

#### 07/06/2019

**Export price index:** Compared with the first quarter of the previous year the index signed a decrease by 1.6 %. "Mining and quarrying" section signed the largest decrease by 1.5%.

**Quarter changes: Producer Price Index** decreased by 0.2 % compared with fourth quarter 2018. The largest decrease is signed in the "Mining and quarrying" section by 1.7 % followed by the section "Electricity, gas, steam and air conditioning" by 0.4%. On the other side Producer Price Index in "Manufacturing" section signed an increase by 0.1 %. Within this section "Manufacture of fabricated metal products, except machinery and equipment" activity increased by 0.9 % followed by "Manufacture of leathers and leather products" by 0.8 % and "Manufacture of dressing: wearing apparel" activities by 1.0 %.

Producer Prices Index for Domestic Market: Prices have maintained the same level with the previous quarter.

**Export Price Index:** Compared with the previous quarter the index signed a decrease by 1,0 %. The main impact on this decrease was given by "Mining and quarrying" section by 3.0 %.

# Metodology

# **User information**

INSTAT calculates Producer Price Index for Domestic Production and Export Price Index. Calculation and publication of Producer Price Index in Albania include:

- Producer Price Index in Total
- Producer Price Index for Domestic Production
- Export Price Index

Producer price index measures the change in the prices of products at the first point of sale after production. Producer Price Index is compatible with Eurostat methodology and covers following economic activities:

- Section B Extracting industry
- Section C Manufacturing industry
- Section D Electric power. water and gas
- Section E Water supply, treatment activities and waste management

These indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA) in 6 – digit level and are published in two digit level. Renovation of the basket of enterprises and products is based on the results of Annual Structural Survey of Enterprises. For calculation of products 'weights of Producer Price Index for Domestic Production are used data coming from SBS while for calculation of products' weights of Export Price Index are used data coming from Foreign Trade Statistics.

Producer Price Index (PPI) is calculated taking into consideration 2010 as base year (2010 = 100). Calculation's method used in compiling of this index is Laspayer chain – index. It means that each transaction will be compared with its previous year December price (y -1).

#### Index calculation

For calculation of index is used Laspeyer type and is calculated as following:

- The first part before the equal sign is stating the price level of December 2009 in percent of the average price level during 2010. hence adjusting the average of 2010 to 100.
- The second term is the chained index movement from December 2010 to December y-1 (a product of yearly index links [short-term links] from December to December).
- The last part is showing the movement from December y-1 to month m year y.

#### Measures of index

The annual change measures the price change between the current quarter and the same quarter of

previous year. This measures is responsive to recent changes in price levels but can be influenced by one -

off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
