# **Movements of citizens in Albania**

## June 2019

#### Tirana 23 July 2019:

Arrivals of Albanian and foreign citizens to the territory of Albania, in June 2019 are 1.080.464, compared to June 2018, this indicator increased 18.4 %. In June 2019, arrivals of foreign citizens in the country are 630.334. Compared to June 2018, this number increased by 27.0 %.

The number of foreign citizen arrivals to the territory of Albania during the first six months of 2019, is 2.136.952, increasing by 11.3 %, compared with the same period of 2018. In June 2019, among the countries with the highest incomes of citizens in Albania, Switzerland had the highest growth by 55.4%, while the largest decrease is 7.4 % by the citizens of Poland.

In the first six months of 2019, the country with the highest inflows of citizens in Albania is Switzerland by 34.6 %, while Poland had the lowest income of citizens with a decrease of 6.4%.




Fig. 1 Movements of citizens in Albania

Albanian and foreign citizen's departures from the country during June 2019 are 1.103.782 marking an increase by 23.3 % compared to the same period of the previous year. Departures of Albanian citizens from the territory of Albania during June 2019 are 459.567 and compared to June 2018, this number has increased by 11.8 %. Departures of foreign citizens from the territory of Albania during June 2019 are 644.215. Compared to June 2018, this number increased by 33.0 %.

The number of Albanian citizens leaving the territory of our country in the first six months of 2019 is 2.656.440 increasing by 10.9% compared to the same period of the previous year.

## Methodology

The purpose of the publication for arrivals and departures of Albanian and foreign citizens, by means of transport (sea, air, land and border points), is the measurement of some statistical indicators related to tourism.

### Definitions

**Arrivals :** Include all entries at the border points (by, air, sea and land). Arrivals is a concept that refers to all entries. A person who visits some countries simultaneously during the year is counted every time as a new entry.

**Departures:** Includes all exits at the border points. Departures measure the flow of citizens who leave the country of reference. A person who leaves the country of reference several times during a year is always counted as a new exit.

**Visitor:** For statistical purposes on tourism, the term "visitor" represents a "person who travels in a different place from that in which he resides, in a period shorter than 12 months and major aim of travel in the place visited is a non-profit activity".

The purpose of the trip includes visits of visitors and tourists for: Visits for *personal purposes* grouped as follows:

- 1. Holidays, visit to relatives, etc.;
- 2. Health treatment;
- 3. Religious;
- 4. Tranzit.

Visits for *Business category* includes all business and professional activities outside the usual environment.

**Data Source**: Administrative data are provided by the Ministry of Internal Affairs (State Police, Border and Migration Directorate).

The statistical differences between arrivals and departures of Albanian or foreign nationals come mainly from:

- Law No.71 / 2016 "On Border Control", Article 17 "Facilitation of Border Verifications", where during the tourist season or increased inflow, at the moment of entry of citizens at the border, does not register all the incoming citizens;
- The facilitating procedures applied to residents of border areas crossing the border due to their commercial activity, when they cross several times a day, are not registered at the entrance;
- A good share of Albanians hold dual citizenship, who at the time of border crossing may declare different citizenship at exit from it at the entrance, etc.
