Consumer Price Index

August, 2019

Tirana, on September 09, 2019: Consumer Price Index in August 2019 arrived 106.5 against December 2015 as reference period.

The annual rate of consumer price index in August 2019 is 1.4 %, a year before this rate was 2.2 %. Compared with July 2019, the monthly change of consumer price index in August 2019 is 0.3 %.





Fig. 1 Annual rate of consumer price index

Contribution of main groups in yearly changes of CPI: Annual growth rate in August was influenced mostly from prices of group "Food and non-alcoholic beverage" by +0.91 p.p. followed by "Housing, water, electricity and other fuel" by +0.16 p.p.. Prices of "Furniture household goods and maintenance" and "Transport" groups contributed by +0.09 p.p. each of them. Prices of "Recreation and culture" group contributed by +0.06 p.p.. Prices of "Alcoholic beverages and tobacco" group contributed by +0.05 p.p.. Prices of "Hotels, coffee-house and restaurants" group contributed by +0.04 p.p.. Prices of "Education service" group contributed by +0.02 p.p.. Prices of "Clothing and footwear" group contributed by +0.01 p.p..

Yearly rates of main groups: Compared to August 2018, prices increased the most in the group "Food and non-alcoholic beverage" by 2.4 %, followed by "Recreation and culture" group by 2.2%, "Alcoholic beverages and tobacco" and "Furniture household goods and maintenance" by 1.5 % each of them, "Transport" by 1.2 %, "Hotels, coffee-house and restaurants" by 1.1 %, "Housing, water, electricity and other fuel" and "Education service" groups by 0.6 % each of them, "Clothing and footwear" by 0.2 %, etc.

On the other side prices of "Health" group signed a decreased by 0.1 %. Within the food group prices of "fruit" subgroup signed an increased by 11.4 %, followed by, "milk, cheese and eggs" by 3.0 %, "vegetables include potatoes" by 2.7 %, "fish" by 1.8 %, "sugar, jam honey, syrup, chocolates and sweets" by 1.2 %, etc. On the other hand prices of "oil and fat" subgroup are decreased 0.7 %.

Monthly rates of main groups: Compared with July 2019 prices of "Transport" group increased by 1.6 %, followed by "Recreation and culture" by 1.5 %, "Food and non-alcoholic beverage" and "Furniture household goods and maintenance" by 0.4 % each of them, "Alcoholic beverages and tobacco" by 0.2 %. On the other the prices of "Clothing and footwear" group are increased by 1.2 %.

Methodology

- Methodological changes

In January of each year some methodological changes and new developments were carried out in CPI:

- Update of weights: Weights are changed; they are now based on the average expenditure from 2017 Household Budget Survey.
- Update of basket: The list of goods and service content 331 products.
- Update of list of the outlets where the prices are collected is updated.

- Definitions

The annual rate measures the price change between the current month and the same month of the previous year. This measure is responsive to recent changes in price levels but can be influenced by one-off effect in either month

The monthly rate measures the price change between current month and previous month. Although upto-date it can be affected by seasonal and other effects.

The 12-month average rate compares average Consumer Price Indices and the latest 12 month to the average of the previous 12 months.
