


Foreign Trade in Goods

September 2019

Tirana, October 17, 2019: On September 2019 the value of exports was ALL 25 billion, decreasing by 5.5 % compared with the same period of previous year and increasing by 23.4 % compared with August 2019. The value of imports was ALL 52 billion, increasing by 2.0 % compared with the same period of previous year and by 0.7 % compared with August 2019. This month the trade deficit is ALL 27 billion, signing an increase by 10.0 % compared with September 2018 and decreasing by 13.7 % compared with August 2019.

In nine months of 2019, the value of exports was ALL 225 billion, decreasing by 2.8 %, compared with previous year and the value of imports was ALL 481 billion, increasing by 3.0 % compared with previous year. Trade deficit was ALL 256 billion, increasing by 8.8 % compared with the same period of 2018.

The influence of the main groups in the annual change in exports:

In annual decrease of exports by 5.5 % this month, a negative contribution was given by the groups: "Construction materials and metals" with -4.4 perecentage point, "Textile and footwear" with -3.8 perecentage point, "Chemical and plastical products" with -0.8. percentage point. While, a positive contribution was given by the groups: "Minerals, fuels, electricity" with +2.4 perecentage point, "Machinery, equipment spare parts" with +0.7 percentage point, "Food, beverages, tobacco" with +0.5 perecentage point.


Fig.2 Contribution of groups in annual change of exports, September 2019

Exports in nine months of 2019 are decreased by -2.8 % compared with the same period of previous year. The main groups that influenced more in annual decrease of exports are: "Minerals, fuels, electricity" with -3.3 percentage point, "Construction materials and metals" with -2.3 percentage point, "Textile and footware" with -1.2 percentage point. While, a positive contribution was given by the groups: "Machinery, equipment spare parts" with +1.7 percentage point "Food, beverages, tobacco" with +1.3 percentage point, "Chemical and plastical products" with +0.6 percentage point.

The influence of the main groups in the annual change in imports:

In annual increase of imports by 2.0 %, this month has mainly affected the groups: "Chemical and plastical products" with +1.6 percentage point, "Food, beverages, tobacco" with +0.7 percentage point, "Minerals, fuels, electricity" with +0.5 percentage point. While, a negative contribution was given by the group: "Construction materials and metals" with -0.6 percentage point, "Machinery, equipment spare parts" with -0.6 percentage point, and "Leather and leather manufactures" with -0.3 percentage point.

In nine months of 2019, imports are increased by 3.0 % compared with the same period of previous year. The groups affected positivity in annual increase of imports, are: "Minerals, fuels, electricity" with +2.4 percentage point, "Construction materials and metals" with +0.7 percentage point and "Food, beverages, tobacco" with +0.4 percentage point. While a negative contribution was given by the group: "Machinery, equipment spare parts" with -0.5 percentage point, "Leather and leather manufactures" with -0.2 percentage point.

The performance of trade in goods by partner countries

In September 2019, countries with which Albania has had the highest increase of exports, compared to September 2018 are: Spain (6.0 %), Germany (6.4 %) and China (165.6 %). While, countries with which has had a decrease of exports are: Italy (-5.9 %), Kosovo (-6.2 %) and Greece (-3.7).


In nine months of 2019, countries with which Albania has had the highest increase of exports, compared to the same period of 2018 are: Kosovo (16.2 %), Germany (6.0 %) and China (16.3 %). While, countries with which has had a decrease of exports are: Italy (-2.1 %) Spain (-16.1 %) and Greece (-2.7 %).

In September 2019, countries with which Albania has had the highest increase of imports, compared to August 2018 are: Turkey (+30.2 %), Greece (+4.1 %), and China (+4.6 %). While countries with which has had a decrease of imports are: Italy (-5.5 %), Germany (-8.4 %), Greece (-5.9 %) and Serbia (-28.4 %).

In nine months of 2019, countries with which Albania has had the highest increase of imports, compared to the same period of 2018 are: China (16.5 %), Turkey (10.0 %) and Greece (7.9 %). While, countries with which has had a decrease of exports are: Italy (-5.5 %), Germany (-8.4 %) and Serbia (-28.4 %).

Trade with the EU countries is 63.7 % of total trade. In September 2019, exports to EU countries occuped 77.7 % of total export and imports from EU countries occuped 57.1 % of total import. The main trade partners remain: Italy (33.0 %), Turkey (8.1 %), Greece (7.9 %) and Germany (6.0 %).

Trade with the EU countries, in nine months of 2019 is 64.4 % of total trade. In this period, the share of exports to EU countries was 76.2 % of total export and share of imports from EU countries was 58.8 % of total import. The main trade partners are: Italy (32.9 %), Greece (7.3 %), Turkey (6.2 %) and Germany (6.2 %).

Methodology

Definitions

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
