




Producer price Index

Third quarter, 2019

Tirana, 05 December 2019: In third quarter 2019, Producer Price Index reached 102.4, decreasing by 1.6 %, compared with third quarter 2018.

Producer Price Index, in third quarter 2019, decreased by 0.8 % compared with second quarter 2019.



Annual change: Producer Price Index in "Manufacturing" section decreased by 1.2 % compared with third quarter 2018. The annual decrease in prices in this section was mainly impacted by "Metallurgy" by 7.4 % followed by "Manufacture of food products" activity by 0.9 % and "Manufacture of dressing: wearing apparel" by 0.4 %. Producer Price Index in "Mining and quarrying" section decreased by 8.5 % compared with third quarter 2018. Within this section prices decreased the most in "Extraction of crude petroleum and natural gas, auxiliary services" activity by 12.9 %.

Producer Price Index for Domestic Market: Compared with the same period of 2018 the index signed a decrease by 0.4 %. The index in the "Mining and quarrying" section signed a decrease by 5.6 % and 0.2 %.

Export price index: Compared with the second quarter of the previous year the index signed a decrease by 5.0 %, mainly impacted by the decrease of "Mining and quarrying" section by 9.9 %.

Quarter changes: Producer Price Index decreased by 0.8 % compared with second quarter 2019. Mostly quarterly decrease by 5.9 % it was mainly it was notice in "Mining and quarrying" section. Producer Price Index in "Manufacturing" section signed a decrease by 0.2 %. Within this section "Manufacture of food products" activity decreased by 0.6 % and "Manufacture of dressing: wearing apparel" by 0.7 %.

Producer Prices Index for Domestic Market: Compared with the second quarter 2019 the index signed a decrease by 0.7 %, where can be mentioned decrease of "Mining and quarrying" by 6.1 %.

Export Price Index: Compared with the previous quarter the index signed a decrease by 1.3 %. Most decrease it was notice by "Mining and quarrying" section by 5.5 %.

Metodology

INSTAT calculates Producer Price Index for Domestic Production and Export Price Index. Calculation and publication of Producer Price Index in Albania include:

- Producer Price Index in Total
- Producer Price Index for Domestic Production
- Export Price Index

Producer price index measures the change in the prices of products at the first point of sale after production. Producer Price Index is compatible with Eurostat methodology and covers following economic activities:

- Section B Extracting industry
- Section C Manufacturing industry
- Section D Electric power, water and gas
- Section E Water supply, treatment activities and waste management

These indices are calculated for each product classified according to the Classification of Products by Economic Activity (CPA) in 6 – digit level and are published in two digit level. Renovation of the basket of enterprises and products is based on the results of Annual Structural Survey of Enterprises. For calculation of products 'weights of Producer Price Index for Domestic Production are used data coming from SBS while for calculation of products' weights of Export Price Index are used data coming from Foreign Trade Statistics.

Producer Price Index (PPI) is calculated taking into consideration 2010 as base year (2010 = 100). Calculation's method used in compiling of this index is Laspayer chain – index. It means that each transaction will be compared with its previous year December price (y -1).

Index calculation

For calculation of index is used Laspeyer type and is calculated as following:

- The first part before the equal sign is stating the price level of December 2009 in percent of the average price level during 2010. hence adjusting the average of 2010 to 100.
- The second term is the chained index movement from December 2010 to December y-1 (a product of yearly index links [short-term links] from December to December).
- The last part is showing the movement from December y-1 to month m year y.

Measures of index

The annual change measures the price change between the current quarter and the same quarter of previous year. This measures is responsive to recent changes in price levels but can be influenced by one – off effects in either quarter.

Quarterly change measures the price changes between current quarter and previous quarter.
