




Foreign Trade in Goods

November 2019

Tirana, December 18, 2019: On November 2019 the value of exports was ALL 25 billion, decreasing by 9.1 % compared with the same period of previous year and increasing by 8.6 % compared with October 2019. The value of imports was ALL 53 billion, decreasing by 5.8 % compared with the same period of previous year and by 10.8 % compared with October 2019. This month the trade deficit is ALL 28 billion, decreasing by 2.7 % compared with November 2018 and decreasing by 12.6 % compared with October 2019.

Fig.1 Annual change in Foring Trade (%)




In eleven months of 2019, the value of exports was ALL 277 billion, decreasing by 4.1 %, compared with previous year and the value of imports was ALL 593 billion, increasing by 2.1 % compared with previous year. Trade deficit was ALL 317 billion, increasing by 8.2 % compared with the same period of 2018.

The influence of the main groups in the annual change in exports:

In annual decrease of exports by 9.1% this month, a negative contribution was given by the groups: "Textile and footware" with -5.1 percentage point, "Construction materials and metals" with -4.5 percentage point and "Wood manifactures and article of paper" with -2.0 percentage point. While, a positive contribution was given by the groups, "Minerals, fuels, electricity" with +1.8 percentage point, "Machinery, equipment spare parts" with +0.3 percentage point and "Chemical and plastical products" with +0.2 percentage point.

Fig.2 Contribution of groups in annual change of exports, November 2019 (p.p)




Exports in eleven months of 2019 are decreased by -4.1 % compared with the same period of previous year. The main groups that influenced more in annual decrease of exports are: "Minerals, fuels, electricity" with -2.7 percentage point, "Construction materials and metals" with -2.6 percentage point, "Textile and footware" with -1.6 percentage point. While, a positive contribution was given by the groups: "Machinery, equipment spare parts" with +1.1 percentage point "Food, beverages, tobacco" with +1.0 percentage point, "Chemical and plastical products" with +0.5 percentage point.

The influence of the main groups in the annual change in imports:

In annual decrease of imports by 5.8 %, this month has mainly affected the groups: "Machinery, equipment spare parts" with -0.3 percentage point, "Minerals, fuels, electricity" with -2.6 percentage point, "Construction materials and metals" with -1.4 percentage point. While, a positive contribution was given by the group: "Food, beverages, tobacco" with +0.8 percentage point, "Wood manifactures and article of paper" with +0.6 percentage point and "Chemical and plastical products" with +0.5 percentage point.

In eleven months of 2019, imports are increased by 2.1 % compared with the same period of previous year. The groups affected positivity in annual increase of imports, are: "Minerals, fuels, electricity" with +1.8 percentage point, "Food, beverages, tobacco" with +0.5 percentage point, and "Construction materials and metals" with +0.3 percentage point. While a negative contribution was given by the group: "Machinery, equipment spare parts" with -0.6 percentage point, "Leather and leather manufactures" with -0.2 percentage point and "Textile and footwear" with -0.1 percentage point.

The performance of trade in goods by partner countries


In November 2019, countries with which Albania has had the highest increase of exports, compared to November 2018 are: Spain (37.8 %), Germany (0.1 %) and Greece (1.5 %). While, countries with which has had a decrease of exports are: Italy (-12.8 %), Kosovo (-9.6 %) and China (-10.0).

In eleven months of 2019, countries with which Albania has had the highest increase of exports, compared to the same period of 2018 are: Kosovo (10.6 %), Germany (5.2 %) and China (11.1 %). While, countries with which has had a decrease of exports are: Italy (-3.6 %) Spain (-9.2 %) and Greece (-4.0 %).

In November 2019, countries with which Albania has had the highest increase of imports, compared to November 2018 are: Turkey (+28.2 %), Switzerland (+58.4 %), and Poland (+12.7 %). While countries with which has had a decrease of imports are: Italy (-5.1 %), China (-0.8 %), and Germany (-5.8 %).

In eleven months of 2019, countries with which Albania has had the highest increase of imports, compared to the same period of 2018 are: Turkey (12.9 %), China (12.9 %), and Greece (7.3 %). While, countries with which has had a decrease of imports are: Italy (-5.9 %), Germany (-7.3 %) and Serbia (-39.4 %).

Trade with the EU countries is 65.3 % of total trade. In November 2019, exports to EU countries occuped 78.3 % of total export and imports from EU countries occuped 59.3 % of total import. The main trade partners remain: Italy (33.2 %), Turkey (8.2 %), China (7.2 %) and Germany (7.0 %).

Trade with the EU countries, in eleven months of 2019 is 64.3 % of total trade. In this period, the share of exports to EU countries was 76.5 % of total export and share of imports from EU countries was 58.5 % of total import. The main trade partners are: Italy (32.7 %), Greece (7.1 %), China (6.9 %) and Turkey (6.5 %).

Methodology

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.

Member State of European Union: Belgium, Germany, France, Italy, Luxembourg, Netherlands, United Kingdom, Denmark, Ireland, Greece, Spain, Portugal, Austria, Finland, Sweden, Cyprus, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Slovakia, Slovenia, Bulgaria, Romania, Croatia.
