


Foreign Trade in Goods

January 2020

Tirana, February 17, 2020: On January 2020 the value of exports was ALL 23 billion, increasing by 5.2 % compared with the same period of previous year and by 4.9 % compared with December 2019. The value of imports was ALL 42 billion, decreasing by 0.7 % compared with the same period of previous year and by 24.8 % compared with December 2019. This month the trade deficit is ALL 19 billion, decreasing by 7.1 % compared with January 2019 and by 44.1 % compared with December 2019.

The influence of the main groups in the annual change in exports:

In annual increase of exports by 5.2% this month, a positive contribution was given by the groups: "Minerals, fuels, electricity" with +2.8 perecentage point, "Construction materials and metals" with +2.1 perecentage point, "Machinery, equipment spare parts" with +1.4 percentage point. While, a negative contribution was given by the groups, "Textile and footware" with -2.3 percentage point, and "Leather and leather manufactures" with -0.06 percentage point.


Fig.2 Contribution of groups in annual change of exports, January 2020



The influence of the main groups in the annual change in imports:

In annual decrease of imports by 0.7 %, this month has mainly affected the groups: "Minerals, fuels, electricity" with -3.7 percentage point, "Chemical and plastical products" with -0.6 percentage point and "Textile and footware" with -0.4 percentage point. While, a positive contribution was given by the group: "Construction materials and metals" with +1.8 percentage point, "Machinery, equipment spare parts" with +1.8 percentage point.

The performance of trade in goods by partner countries

In January 2020, countries with which Albania has had the highest increase of exports, compared to January 2019 are: Spain (+69.7%), Kosovo (+45.3 %) and Germany (+35.9 %). While, countries with which has had a decrease of exports are: Italy (-6.5 %), China (-44.7) and Turkey (-30.8 %).

In January 2020, countries with which Albania has had the highest increase of imports, compared to January 2019 are: Greece (+19.8 %), Turkey (+21.6 %) and Germany (+19.2 %),. While countries with which has had a decrease of imports are: Italy (-2.8 %), China (-10.5 %), and Usa (-0.7 %).




Fig.4 ForeignTrade in Goods by several EU countries, January 2020

Trade with the EU countries is 75.1 % of total trade. In January 2020, exports to EU countries occuped 73.1 % of total export and imports from EU countries occuped 76.2 % of total import. The main trade partners are: Italy (32.8 %), Greece (8.4 %), Germany (7.1 %) and Turkey (7.0 %).

Methodology

Exports are goods destined to a third country, placed under customs export or outward processing arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under customs procedure of release for free circulation, inward processing or processing under customs control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing country, or the price of a service delivered to resident, before the payment of any import duties or other taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics and for customs tariffs.
