## **Movements of citizens in Albania**


## January 2020

**Tiranë më 24 February 2020:** Arrivals of Albanian and foreign citizens to the territory of Albania, in January 2020 are 693,956.

Compared to January 2019, this indicator increased 20.9 %. In Januaryr 2020, arrivals of foreign citizens in the country are 249,461. Compared to January 2019, this number increased by 19.1 %.

In January 2020, the country with the highest inflows of citizens in Albania is Poland by 38.9 %, while Swizerland has the lowest income of citizens with a decrease of 1.2 %

Albanian and foreign citizen's departures from the country during January 2020 are 842,694 marking an increase by 21.5 %, compared to the same period of the previous year. Departures of Albanian citizens from the territory of Albania during January 2020 are 531,065. Compared to January 2019, this number has increased by 17.0 %. Departures of foreign citizens from the territory of Albania during January 2020 are 311,629. Compared to January 2019, this number increased by 29.9 %.

# Methodology

The purpose of the publication for arrivals and departures of Albanian and foreign citizens, by means of transport (sea, air, land and border points), is the measurement of some statistical indicators related to tourism.

### Definitions

Arrivals : Include all entries at the border points (by, air, sea and land).

Arrivals is a concept that refers to all entries. A person who visits some countries simultaneously during the year is counted every time as a new entry.

**Departures:** Includes all exits at the border points. Departures measure the flow of citizens who leave the country of reference. A person who leaves the country of reference several times during a year is always counted as a new exit.

**Visitor:** For statistical purposes on tourism, the term "visitor" represents a "person who travels in a different place from that in which he resides, in a period shorter than 12 months and major aim of travel in the place visited is a non-profit activity".

The purpose of the trip includes visits of visitors and tourists for: Visits for *personal purposes* grouped as follows:

1. Holidays, visit to relatives, health treatment etc.;

- 2. Religious;
- 3. Tranzit.

Visits for Business category includes all business and professional activities outside the usual environment.

The statistical differences between arrivals and departures of Albanian or foreign nationals come mainly from:

- Law No.71 / 2016 "On Border Control", Article 17 "Facilitation of Border Verifications", where during the tourist season or increased inflow, at the moment of entry of citizens at the border, does not register all the incoming citizens;
- The facilitating procedures applied to residents of border areas crossing the border due to their commercial activity, when they cross several times a day, are not registered at the entrance;
- A good share of Albanians hold dual citizenship, who at the time of border crossing may declare different citizenship at exit from it at the entrance, etc.
