


# **Foreign Trade in Goods**

## October 2020

**Tirana, November 17, 2020:** On October 2020 the value of exports was ALL 27 billion, decreasing by 0.9 % compared with the same period of previous year and increasing by 6.0 % compared with September 2020. The value of imports was ALL 59 billion, decreasing by 0.01 % compared with the same period of previous year and increasing 13.1 % compared with September 2020. This month the trade deficit is ALL 33 billion, increasing by 0.8 % compared with October 2019 and by 19.7 compared with September 2020.

Fig.1 Annual change in Foring Trade, October 2020 (%)




In the first ten months of 2020, the value of exports was ALL 221 billion, decreasing by 12.2 %, compared with previous year and the value of imports was ALL 488 billion, decreasing by 9.7 % compared with previous year. Trade deficit was ALL 267 billion, decreasing by 7.6 % compared with the same period of 2019.

### The influence of the main groups in the annual change in exports:

In annual decrease of exports by 0.9 % this month, a negative contribution was given by the groups: "Minerals, fuels, electricity" with -5.0 percentage point, "Textile and footware" with -2.1 percentage point, "Leather and leather manufactories" with -0.4 percentage point. While a positive contribution was given by the groups: "Food, beverages, tobacco" with +2.7 percentage point, "Construction materials and metals" with +2.0 percentage point, "Machinery, equipment spare parts" with +1.9 percentage point.

Fig.2 Contribution of groups in annual change of exports, October 2020 (p.p)




Exports during the first ten months of 2020 are decreased by -12.2 % compared with the same period of previous year. The main groups that influenced more in annual decrease of exports are: "Textile and footware" with -6.2 percentage point, "Minerals, fuels, electricity" with -3.8 percentage point, "Construction materials and metals" with -2.3 percentage point. While a positive contribution was given by the group: "Food, beverages, tobacco" with +1.1 percentage point.

#### The influence of the main groups in the annual change in imports:

In annual decrease of imports by 0.01 %, this month has mainly affected the groups: "Minerals, fuels, electricity" with -3.3 percentage point, "Leather and leather manufactories" with -0.4 percentage point, "Wood manufactories and article of paper" with -0.1 percentage point. While, a positive contribution was given by the groups: "Machinery, equipment spare parts" with +2.4 percentage point, "Construction materials and metals" with +0.6 percentage point.

In the first ten months of 2020, imports are decreased by 9.7 % compared with the same period of previous year. The groups affected negativity in annual increase of imports, are: "Minerals, fuels, electricity" with -4.0 percentage point, "Textile and footwear" with -2.2 percentage point, "Machinery, equipment spare parts" with -1.5 percentage point.

### The performance of trade in goods by partner countries


In October 2020, countries with which Albania has had the highest increase of exports, compared to October 2019 are: Kosovo (9.7 %), Germany (63.0 %) and Greece (22.4 %). While, countries with which has had a decrease of exports are: Italy (-0.6 %), Spain (-62.5 %), and China (-11,1 %).

In the first ten months of 2020, countries with which Albania has had the highest increase of exports, compared to the same period of 2019 are: Germany (14.3 %), North Macedonia (0.6 %), and Serbia (43.0 %). While, countries with which has had a decrease of exports are: Italy (-16.6 %), Kosovo (-17.5 %) and Spain (-24.1 %).

In October 2020, countries with which Albania has had the highest increase of imports, compared to October 2019 are: Italy (9.0 %), Greece (17.6 %) and Germany (24.0 %). While countries with which has had a decrease of imports are: Turkey (-16.2 %), Serbia (-3.2 %) and SwitzerInd (-35.1 %).

In the first ten months or 2020, countries with which Albania has had the highest increase of imports, compared to the same period of 2019 are: Germany (0.8 %), Serbia (34.9 %) and Russia (17.7 %). While, countries with which has had a decrease of imports are: Italy (-11.7 %), Turkey (-4.6 %) and Greece (-5.7 %).

Trade with the EU countries is 65.0 % of total trade. In October 2020, exports to EU countries occuped 74.7 % of total export and imports from EU countries occuped 60.6 % of total import. The main trade partners remain: Italy (32.8 %), Germany (8.4 %), Greece (7.7 %), China (6.6 %).

Trade with the EU countries, in the first ten months of 2020 is 63.2 % of total trade. In this period, the share of exports to EU countries was 75.2 % of total export and share of imports from EU countries was 57.8 % of total import. The main trade partners are: Italy (31.4 %), Greece (7.7 %), Germany (7.3 %) and Turkey (6.8 %).

Methodology

Exports are goods destined to a third country, placed under customs export or outward processing

arrangements or re-exported following inward processing.

The FOB (free on board) value of exports of goods is the value of the goods at the exporter's customs

frontier.

Imports are goods arrived from a third country and are directly placed, or are left in warehouse, under

customs procedure of release for free circulation, inward processing or processing under customs

control.

The cost, insurance and freight (CIF) price is the price of a good delivered at the frontier of the importing

country, or the price of a service delivered to resident, before the payment of any import duties or other

taxes on imports or trade and transport margins within the country.

Combined Nomenclature (CN) is a goods nomenclature used by international trade in goods statistics

and for customs tariffs.

Member State of European Union: Belgium, Germany, France, Italy, Luxembourg, Netherlands,

Denmark, Ireland, Greece, Spain, Portugal, Austria, Finland, Sweden, Cyprus, Czech Republic, Estonia,
